Chairwoman Donna Bovee called the meeting to order at 6:04 p.m.

## Meeting Agenda

#### 1. Audience of Citizens

Lisa Deseno, 212 Beckley Road, would like to request having a race in Berlin for ALS Alliance at Pistol Creek. She will be charging \$20 to register. Last year she had 70 people registered. No police came to the event last year. Looking to do it Saturday, May 18th. They did not have any issues with the park being still open to the public. Because she is charging a fee, the Commission would have to approve it, then the Town Council will have to vote too. Last year, Jen Ochoa, Director of Community, Recreation and Park Services, gave the Police Department a heads up and she would do the same again this year. The Police Department may or may not decide to have police presence. She is requesting permission for the ALS Alliance to charge \$20 for their 5k registration.

Commissioner Don Delaquilla is motioning to add the following to the agenda under the consent agenda.

To request permission by ALS Alliance to charge a fee of \$20 for their 5k run/walk Event that will take place at Pistol Creek on May 18, 2024.

4. Update on Demore, Dinda, Bittner Jr. Memorial Pool. Chairwoman Bovee attended the Town Council meeting and they did not vote to close the pool yet. They were also there to support a feasibility study to be led by Steve Wood, Superintendent of Parks & Grounds. Chairwoman Bovee requested their approval so by the end of the year they will be in a better position to give a report on the status of the pool.

## 5. Parks and Recreation

a. Monthly Report, Debbie Dennis, Superintendent of Recreation, stated the Tinsel Run was great. 141 people finished the run out of 145 registered. The Holiday House Decorating contest is going great. Basketball started last week and the games went pretty well. The Theater Guild held their Nutcracker performance and she discussed doing future things with them. She expects that she will be okay with returning staff but is aiming to hire more staff than we need so we do not end up short life guards.

#### 6. Parks & Grounds

- a. Monthly Report, Jen Ochoa, Director of Community, Recreation and Park Services wanted to note that the bench has been installed at the High School, it is the Chase Anderson Memorial Bench.
- b. State of CT Grant Update, Jen Ochoa, Director of Community, Recreation and Park Services, stated the field is open. We will do a big opening in the Spring. Percival Field is finished and the field was a bit wet but will be ready in Spring. We also paved the walkway to Percival Field as part of the project. The Berlin Little League has a new President. Steve Wood and Jen Ochoa had a meeting with him and he would like to have better communication with Steve Wood and the department about their needs for the field. Jen Ochoa suggested that we start meeting with specific teams and their field usage. Her and Steve Wood will look into the issue. Berlin Youth Soccer will have Percival field back which will be helpful with the scheduling. They will touch base with the American Legion President and Berlin Little League President to work together to use the fields just as they did in the Fall. The new signage went up this week at Biscoglio with the new rules because it is turf now.

Commissioner Don Delaquilla made a motion to add a new item to the agenda discussing the Community Senior Center.

Seconded by Commissioner Butrimas.

Chairwoman Bovee discussed that the Town Council would like to request our Parks and Recreation Commission to adjust the statement of need submitted that is from 2021. The general thought was that the statement of need was too expensive. The Town Council did discuss bringing in a facility. The revisions would be a town funded community senior center but focussed on reducing the size of it. The Town will be hiring a new architect for this project, to ultimately bring both options to referendum. There will be a combined statement of need from the Parks and Recreation Commission and the Commission for the Aging. Chairwoman Bovee did ask the Town Council to tell us how much they were willing to spend but they declined to. Chairwoman Bovee has reached out to the High School for any updates/changes they have for it. She asked the Town Council for a timeline and they estimated April. The architect the town typically uses is Jacunski Humes Architects..

#### 7. Adjournment

Commissioner Starr motioned to adjourn at 7:03 pm.
