Chairman Lucas VanZandt called the meeting to order at 6:00 p.m.

Meeting Agenda

1. Audience of Citizens

- a. Linda Kozlenko, 17 Streamside Lane, part of a group of quilters in town and out of town residents that meet regularly to quilt together. They are hoping to rent a space in the Community Center to quilt together. The group would pay the non-resident fee.
- b. Carol Thompson, 421 Savage Hill Road, is also part of the quilter group. They would like the space to quilt together.
- c. Mark Cichocki, 400 Percival Avenue, believes the town would benefit from a community spot where kids can skateboard and bicycle. He described the benefits to having an area dedicated to these activities such as creating resilience, stress release, positive skills, etc. The emphasis is having a facility that has half pipes, ramps, etc. that are built safely and are regulated. There are a few companies that build these but would be around 1 million dollars for the project.
- d. Colin Asklar, 156 Overhill Drive, wanted to ask about potential locations a Skate Park could go within the Town.
- e. Emilie Jensen, 16 Edgerly Street, wanted to ask about splitting portions of the project for a Skate Park in the future with crowdsourcing.
- f. Noah Cichocki, 400 Percival Avenue, wanted to express that they would be interested in gathering data from their classmates to guage interest.
- g. Tai Cichocki, 400 Percival Avenue, believes it's a common issue that parents leave Berlin to access facilities in other towns and urges the town to think about adding a Skate Park as another amenity parents are seeking.

Discussion pertaining to location that the Skate Park could potentially be were discussed due to the logistics of it wanting to be a 24/7 available location. It was suggested that the citizens interested in this project to keep building momentum in town about it and discussing it with other

townsmembers. It was also suggested that they coordinate and do research on the project they are proposing.

4. Parks and Recreation

- a. Monthly Report, Debbie Dennis, Superintendent of Recreation, discussed the Tinsel Run and excitement towards it around town. Trunk or Treat was a success as well. Commissioner Boyce wanted to ask about their budget and the timeline for our Capital budget meetings. Steve Wood, Superintendent of Parks & Grounds, listed items on the Capital Budget list such as redoing the bridge at Veterans Park, irrigation pump at Sage should be replaced, they need a new pickup truck and a large area mower, redoing the Community Playground geared for teenagers/more athletic tasks, redoing sidewalks at McGee.
- b. Group Rental at Community Center, Debbie Dennis, Superintendent of Recreation, wanted the Commission to approve their usage because of its unique request. The Commission supports the group renting a room.

5. Parks & Grounds

a. Monthly Report, Steve Wood, Superintendent of Parks & Grounds, the food pantry delivery to Pistol Creek and the event was a success and thank you to Social Services for doing that project. The lip on the backside of Centurelli was fixed and updated with sod. The Town celebrated 250th at Meeting House, the event was great and coordinated the rental of the

- chairs. Signage was hung in time for Senior Night's for Soccer and Football. The Luminaries also looked great in town.
- b. Demore, Dinda, Bittner Jr. Memorial Pool Complex Project Update, Chairman VanZandt updated on the Commission meeting. There were a few options sent to them about this project and they unanimously chose a contractor; Weston and Samson. Commissioner Bovee also expressed the process was easy to navigate so far and their commission will then vote on the project the contractor proposes. This is on the Town Council agenda for November 25th. The project's proposed cost is \$365,400.

Discussion by the Commissioners about the investment in Cameras for Sage Park because of the motorized bikes and incidents damaging the fields.

Commissioner Bovee motioned to approve their choice of Weston and Samson as a contractor. Seconded by Commissioner Starr.

- 1. Winter class registration is going on now.
- 2. Numbers for December special events Santa's Parlor 38 kids, down from last year. We cancelled Tuesday, due to the weather, and held it Wednesday.

Tinsel Run 123 people finished, 133 registered. Tinsel Run numbers were great this year, we were very pleased with the turnout.

We will judge the houses for the Holiday House Decorating contest the week of December 15.

- 3. Basketball teams started practicing after Thanksgiving and will start games December 13. We currently have 172 total participants, down slightly from last year. I hired several new staff. I have been working on practice schedules for January.
- 4. Submitted budget for fiscal year 2026-27. Increases for staff based on minimum wage increase by the State for January 2026 and anticipated increase January 2027. I submitted again for a full time Recreation Supervisor position.
- 5. Around the holidays, I will be contacting last year's summer staff to see who will be returning and at the end of the month I will begin advertising for open positions.




