B. Town Manager News:

Fall has arrived and with it comes the beginning of a new budget cycle. With very little definitive news from Hartford, the Town and Board of Education staff have been meeting to prepare contingency plans in anticipation of the State passing a budget. The Capital Planning has begun for the 2018-2019 budget and with it some changes as we look to manage funds available to support the Town's infrastructure and planning needs.

Tollgate Road has been closed due to a release of high pressure hydraulic oil from an old pressurized natural gas line. State of Connecticut Department of Energy and Environmental Protection and Federal Environmental Protection Agency officials are working with Eversource to remediate the site. On the Town side, the Fire Marshal and Health Department are monitoring the situation to insure our residents are represented.

Lastly, unfortunately our Director of Development Services, Hellyn Riggins, has resigned after 14 ½+ years. Her professionalism as Town Planner has served the Town and its citizens well and she will be missed. We wish her well and good fortune as she moves on to the next phase of her life.

C. <u>Department News:</u>

Berlin-Peck Memorial Library

- The elevator has been ordered and a project timeline is in place.
- The Library had a booth at the Berlin Fair this year. While we could only staff it on Friday, we garnered lots of attention with our airbrush tattoo machine that we borrowed from our consortium!
- We have set up a meeting with the Berlin School's new Director of Literacy, Laurie Gjerpen, to discuss library/public school cooperation.

Community and Parks and Recreation Services

Parks and Recreation

• Life Line Screening was at the Community Center in September and 53 people participated in the screenings they offered. Life Line Screening is a leading provider of community-based preventive health screenings. Five screenings were offered that scan for potential health problems related to: blocked arteries which is a leading cause of stroke; abdominal aortic aneurysms which can lead to a ruptured aorta; hardening of the arteries in the legs which is a strong predictor of heart disease; atrial fibrillation or irregular heart beat which

is closely tied to stroke risk; and a bone density screening, for men and women, used to assess the risk of osteoporosis.

- The Kensington Garden Club held a workshop/demonstration at the Community Center in September. Approximately 60 people were expected to attend.
- The 13th annual Scarecrow-Fall Festival will be held on Saturday, October 14th. Opening ceremony will take place at 11 a.m. in Volunteer Park. After the opening ceremony, children's activities will take place in the park until 12:30 p.m. We encourage businesses, volunteer/civic organizations, children organizations as well as individuals and families to create their own unique scarecrow to enter into the Scarecrow contest. Scarecrows will take up residency on Farmington Avenue from Saturday, October 14th until Sunday, October 29th.
- The annual Halloween Monster Bash and Pumpkin Decorating Contest will be held on Friday, October 27th from 6:45 to 8:30 p.m. at Willard School and is for Berlin youth only ages pre-school through 5th grade and their families. Come in costume and enjoy the evening with activities that include members of the Upbeat program and a dj in the gym, various arts and crafts, games, Halloween Bingo and other spooky activities. Come in costume and register for a chance to win a prize; random winners will be picked throughout the night. We are also teaming up with the Willard School PTO as they hold their Trunk or Treat event that night from 6:45 to 8 p.m.
- Fall programs have begun. Registration for winter basketball began on Monday, September 25th for boys in grades 3 through 8 and girls in grades 3 through 9. Information for all programs can be found on the Town of Berlin website.

Senior Center

- September's trips were to 9/11 Memorial and Museum, Newport Playhouse Lobsterfest Matinee, BIG E, and the Intrepid.
- September's Lunch Bunch Trip was to Bill's Seafood in Westbrook.
- Specialty Shopping Trips in September were to Walmart in Cromwell and The Christmas Tree Shoppes in Manchester.
- The movies for September were "Gifted" and "Going in Style".
- This month the Center held two "special" bingo September 14th was provided by Ledgecrest Convalescent Home and September 28th was provided by Newington Rapid Recovery Rehab Center.
- On Friday, September 15th the Center held a magical music program. The food was catered by CW Resources Inc. and sponsored by the Senior Center. Musical entertainment was provided by Jose Paulos.
- Chef Tina conducted a cooking class on Sept 20th on how to prepare delicious appetizers for family and friends.
- A representative from Anthem Blue Cross Blue Shield held a "Get the Scoop on Medicare" Ice Cream Social on September 22nd.

- TED Talks and a brown bag lunch were hosted by Tina were held on September 26th.
- The Senior Center is continuing to take Renters Rebate applications for the State of CT OPM Tax Relief program. The state program ends October 1st.
- Facilities: The Facilities Department approved and completed a total of 433 work orders from various Town departments and schools. In addition to the work orders and the involvement with the Berlin High School renovation project, the following projects have been in progress or completed within the last month:
 - Surplus items are continuing to be sold on GovDeals.com freeing up storage space within buildings for better organization of operating materials.
 - The NORESCO Energy Performance contract received final approval and the project is underway. Facilities will be involved in the project until its completion, which has been extended to later this year.
 - Completed removal of old and installation of new Commercial Grade Fryer at Timberlin, Par for the Course Restaurant.
 - Completed the replacement of the Heating, Ventilation and Air Conditioning (HVAC) System in the Senior Center Multipurpose Room.
 - Painted the walls and flooring and installed locker leveling system for Boys Locker Room at McGee Middle School.
 - Completed all the HVAC filter maintenance throughout all of the Schools and Town buildings.
 - Began the modification of the former Home Economics Classroom to accommodate it into a Keyboard Lab at McGee Middle School.
 - Replaced main kitchen exhaust fan at McGee Middle School.
 - Solar Panels have been activated and are operational at all Elementary Schools and McGee Middle School.
 - Installed air conditioning, electrical and communications wiring at the temporary dispatch center in the Police Department.
 - Built a new wall to create another office space area in the Police Department.
 - Reconfigured the electrical and communication lines to the computer room at Griswold Elementary.
 - Reorganized the Fan Room at Berlin High School to accommodate it as an emergency shelter storage area.
 - Painted the exterior railings at the Timberlin Clubhouse.
- Finance: The Town conducted a Bank Anticipation Notes (BAN) sale on September 6th for \$1,028,000. The Town received four bids and accepted the low bid at 1.19%. The cash settled on September 19th without any issues. This BAN represented the first payments on debt related to the Berlin High School basketball/tennis courts and the generator projects. The remaining repayments were for Business Continuity, roads and bridges. No new money debt was issued.

With continued uncertainty about the level of State funding the Town will receive, cash balances continued to be invested with a short-term strategy. Money market rates are currently over 1% at several institutions, so the Town continued to employ the strategy to invest a high

percentage of available cash with this vehicle until the State budget is finalized. This strategy is intended to provide necessary liquidity when large debt payments are due in September and December as well as covering on-going payroll, benefits, utility and maintenance costs.

The office provided the auditors with supporting information for work in advance of field work this month. All accounting was closed in September and pre-audit financial statements and footnote schedules were developed.

<u>Revenue Collector's Office:</u> On September 18th, Deborah Swan started as the Town's Revenue Collector. Deborah was most recently the Assistant Tax Collector in Guilford and is a Certified Connecticut Municipal Collector.

During September, Lucy Gajewski, the current Interim Tax Collector and long-standing Assistant Tax Collector, announced her retirement effective October 2nd. Lucy was critical to ensuring the office and the Town met all tax requirements (issuing bills, proper accounting of receipts, reconciliations) while the search for a permanent collector was on-going.

September included the collection of delinquent taxes as well as issuing monthly water/sewer bills. At this point, the Town continues to be on-pace to meet budget for tax collections.

<u>Assessor's Office:</u> Applications for the Additional Veterans Exemptions continued to be accepted in July and August. The Veterans runs through October 1st. Letters were mailed to homeowners that need to reapply. Building permits continued to be entered for the upcoming year and permit inspections continued for the 2017 Grand List. Transfers of real estate ownership continued to be processed as part of day-to-day operations.

Inspections and data entry were performed and processed and continued to be on schedule for the 2017 re-valuation. We continued mailings for interior inspections that started in January. These inspections are the ones we were unable to get into when we were there previously. Mailings to the sections remaining for full inspections (exterior and interior) began in March.

The office continued to process Certificate of Corrections for motor vehicles that were sold, stolen, totaled or transferred and for real estate as well. These included omitted items and items prorated for new construction.

<u>Purchasing:</u> The following is a summary of Request for Proposals (RFP's) and other major projects that were worked on during September:

- RFP Sanitary Sewer Connection and Pump Station Abandonment Savage Hill Road RFPs opened September 15th
- RFQ for Berlin Water Control Outsource Billing Services RFQs opened September 18th
- RFQ for Transit Oriented Development Developer Opportunity
- RFP for Payroll, Time and Attendance

Posting of Town/Board of Education surplus assets on GovDeals continues actively, with approximately \$603.00 earned on 13 completed auction listings since the start of Fiscal Year 2018.

- ➤ Public Works/Engineering: The following are activities that continue to be in process, or completed:
 - There were Forty One (41) Excavation Permits during August. We began charging \$10 for Burning Permits July 1, 2017, and there were ten (10) issued in August.

<u>Public Grounds</u>: The following services were provided by the Public Grounds Department during the month of September 2017:

- Replacement of four basketball hoops; three at Griswold School and one at Hubbard School.
- Filled crack and reset the basketball hoop at McGee School.
- Repaired the fence at McGee tennis courts.
- Assisted in the planting and mulching of the T-Cop Memorial flower bed at Berlin High School.
- Relocated the fence and moved 25 feet up the hill next to the basketball courts at Berlin High School.
- Closed and winterized town pools for the season.
- Started to remove silt and replace it with crushed stone on Petit Field 2.
- Completed painting crosswalks, parking lots and stencils in all Town lots.
- Started lining athletic fields in preparation for the fall sports season.

Water Control: The Water Control Commission (WCC) has an on-going project to design and replace the existing booster pump station connection with the Metropolitan District Commission (MDC) of Hartford. The design is complete, with the project likely to start late summer 2017. When complete, the WCC will be able to utilize the half-million gallons per day supply from the MDC (up to one million gallons per day maximum). This pumping station cannot currently be used under normal conditions. Lenard Engineering has been given the contract to develop bid documents and oversight of the construction. LaRosa Construction (as low bidder) has been selected to manage this project. The new booster pump vault is nearly complete. We are studying the timing of the vault installation, likely in October. A schedule is being established for connecting the new vault which has been completed.

We have selected DPC, LLC to evaluate the sewer flows entering the Deming Road Sewer Pump Station. The intent is to evaluate the MDC sewage contribution to this pump station. DPC, LLC flow data is clear that the MDC contributes at least 80% of the flow into the Deming Road Pump Station. An invoice is being prepared for the MDC to be submitted for their share of the pumping service Berlin WCC provides. DPC, LLC was the low bidder for the Rate Study. This review and report should be completed in several months.

Well 1-B is now operational. We still need some work at the well field. The Connecticut Department of Public Health (DPH) has yet to give final approval. All physical connections of piping have been installed. The pump has been installed and re-tested and is fully operational. We are required to do additional copper/lead monitoring as a result of the new well.

The option of offering a *secondary meter* for individual customers utilizing significant outdoor water usage continues to be popular. The Berlin WCC purchased additional meters in the spring of 2016 to maintain an inventory in anticipation of a greater demand for secondary

meters during the summer. Approximately 100 customers have utilized this option and many have expressed how happy they are with it. This year, many homeowners have indicated that they have used their sprinkler systems minimally because rainfall has been sufficient.

We are in the process of working with Lenard Engineering to evaluate the Need and Design of a generator at the Elton Road well field. The report is complete, and staff is in the process of evaluating it and deciding on an option so it can be included in our Capital Improvement Plan (CIP). We anticipate this project will take place during the next fiscal year, possibly in the fall.

The Beckley Road Pressure-Reducing Valve Re-Build is being considered for September, just before we stop purchasing water from Cromwell (this year). Funding has been approved by Town Council.

The project to eliminate the Savage Hill Pump Station (with the engineering completed by MBA Consultants) is on-going. The directional drilling for this project is being re-bid because of the high prices on the first proposals. The second bid notice still has very high bids, so we are considering traditional trenching to evaluate that cost versus directional drilling.

D. Board/Commission News:

F. Project Updates:

- 1. **High School Civil Rights and Accreditation Project:** No Change Ongoing project updates, advisory committee meetings and bi-weekly owner meetings continue to occur along with published monthly updates prepared by Gilbane and placed onto the Town's website. Council receives abbreviated updates monthly as necessary. The project is now 98 percent complete. Contractors are working on punchlist items.
- 2. Infiltration/Inflow Sewer Project: We have received confirmation from the State Department of Energy and Environmental Protection (DEEP) on the viability of financing to undertake additional work within the Belcher Brook Watershed Trunk Line. Cardinal Engineering Associates has developed an Amendment #3 and Amendment #4 approved by Town Council on June 7, 2016. Camera evaluation of the Interceptor has been done. Both the Army Corps and the State DEEP have given the go ahead to proceed with the project. The project went before the Wetlands Commission in May for their approval. The project is being reviewed by

- DEEP. Berlin WCC Staff reviewed the final proposal before the application went to DEEP for funding consideration. We are adjusting the schedule so that it starts in the spring of 2018. We are preparing paperwork to submit to DEEP for a loan request and approval.
- 3. **Street Paving Projects:** No Change Paving is complete on Winchell Drive, Woodruff Lane, Cole Lane, Briar Patch, Rabbit Trail and Partridge Lane. Old Brickyard Lane is currently under re-construction.
- 4. Spruce Brook Bridge Over Spruce Brook: No Change Final design is nearing completion, including the incorporation of the historic elements of the site into the new structure. The local Inland Wetlands and Flood Hazard permits were approved in July. We are awaiting approval of both State and Federal permits. We expect to bid the project this spring, with construction anticipated to begin later this year. Currently, the bridge site is undergoing historic review; Historic Perspectives, Inc. is working with the Berlin Historic Society to minimize impacts to the site. Connecticut Department of Transportation (CT DOT) is working with the state Historic Preservation Office.
- 5. Farmington Avenue Bridge (Over Sebethe River): No Change The bid opening occurred February 11, 2016. The low-bidder was Mastrobattisto, Inc. of Bristol, CT having submitted a bid of \$2,348,391.75. Several change orders have increased costs to approximately 3 million dollars to complete the project. The closure of Farmington Avenue at the site occurred June 16, 2016. Several delays with utility relocations have been encountered. The discovery of contaminated soils adjacent to the westerly abutment, have also delayed the project's progress. The project is approximately 75% complete. The Contractor was allowed to continue work during the winter shutdown period (December through March), weather permitting, in an attempt to bring the project back on schedule. Project completion is now anticipated for early fall of this year.
- 6. Elton Wells Water Control Commission: Our new Well 1B is operational. We are still looking at some operational upgrades at the well field. We will also be required to conduct more testing as a result of the Connecticut Department of Public Health.
- 7. **Burnham Street Bridge and High Road Bridges:** No Change The permitting and easement process is in progress, and final designs have been received. The bids for the High Road project were received and opened on March 23rd. As you are aware, Town Council awarded the project to be constructed by Martin Laviero of Bristol, CT. Due to a recent change in the State DOT construction oversite approvals, the start of construction will be delayed until the spring of 2018 to avoid a winter-long road closure. The Burnham Street Bridge construction is scheduled for 2018.
- 8. Manual on Uniform Traffic Control Devices (MUTCD) Sign Project: No Change The Town has begun a project replacing the traffic signs in compliance with the Federal Highway Standards MUTCD. This work will continue to be an ongoing project for the next several years.
- 9. **Streetscape Improvements:** No Change Cardinal Engineering was chosen as our consultant to work with the second phase of the Streetscape. A meeting was held with property owners

- on Main Street where they were able to express their concerns, expectations and hopes for the next phase.
- 10. Train Station Improvements & 889 Farmington Avenue Remediation: No Change We have been in touch with DOT on the Train Station site, but have received minimal feedback on its future. Additionally, we have requested additional funds to expand the 889 property as well as acquire the rail bed between 889, 903 and 913 Farmington Avenue and the Berlin Steel site.
- 11.1567 Berlin Turnpike Environmental Remediation: No Change An RFP for environmental services is being prepared for environmental testing along with other townowned properties for the fiscal year 2017-2018.
- 12. Façade Grant Program: No Change Applications have recently come in for a few properties. The funds from the second phase of the Façade Program are now being tapped into.
- 13. **Gateway Signs:** No Change The signs have been installed throughout the town and feedback has been very positive.
- 14. **Kensington Village Sidewalk Project:** No Change Complete Services LLC of Oakville, CT was awarded the contract in the amount of \$379,000.00 in May. Work has begun along Kensington Road with an anticipated completion date of October 20, 2017.
- 15. Earl Wicklund (Stick Village): No Change Building 4 is near completion. We are working with the listing agent and owner on finding a tenant for this 5,000 square foot building.
- 16. ACURA/Retail Development: No Change A grand opening will be held in September once the dealership has been occupied. No date yet determined. There has been some interest in the retail building, but no announcements yet.
- 17. **Forrest Machine/Christian Lane Development:** No Change The steel has been put up, the roof and walls are being installed and the building is beginning to take shape. The hope is that by year end, Forrest Machine will be able to occupy the building.
- 18. Berlin High School and Berlin Businesses: No Change A meeting was held at Junior Achievement (JA) with Chris Edge, JA representatives and Patty Pires. A plan was discussed to bring Junior Achievement into Berlin High School for the 2017-2018 school year. This would include in classrooms, job shadowing and some visits to Berlin businesses. Specific details are still being worked out.
