Proposal

Application – Hoa T. Nguyan, Esq. is appealing the decision of the Zoning Enforcement Officer to issue a Cease and Desist Order to Karen Hoang, owner, dated 3/5/2020 per Berlin Zoning Regulations §XV. regarding the keeping of chickens/poultry at the residential property in the R-15 zone.

Zoning Requirements:

§XI.C.8. Agriculture. The Keeping of Animals.

§XV. Zoning Board of Appeals.

A.1. Powers and duties. Appeals.

- B. General rules. Appeals.
- Notice of Zoning Violation Cease and Desist order (NOV) was issued on March 5, 2020.
- The letter was sent Certified Mail, postmarked March 9, 2020 and regular mail. The Certified letter was returned, notified unable to deliver, received April 01, 2020.
- The applicant contacted the zoning office and appealed the order with application dated March 21, 2020 received on April 1, 2020.

In accordance with Berlin Zoning Regulations §XV.A. "1. Appeals. The ZBA shall have the authority to hear and decide upon any appeal where it is alleged that there is an error in the order, requirements, decision or determination of the ZEO. No question of hardship shall be involved in such an appeal, and the action of the ZBA thereon shall be limited to the question of whether or not, and to what extent such order, requirement, decision, or determination was a correct interpretation of the subject provision of these regulations."

Please note that appeals require the file be copied to the ZBA.

Staff Comments

The appeal application is believed to have been properly received, while stamp received on April 1, 2020, which is more than 15 days from the postmark; Planning and Zoning staff was not available to stamp the application the week prior, due to a death in the family and Coronavirus emergency. The date of delivery to Town Hall cannot be confirmed. The Town Hall has been closed to public traffic since March 18, 2020. Mr. Nguyen, attorney for the owner, responded to the order by telephone to discuss the appeal application process and spoke to staff several times. (phone notes attached).

The applicant has not provided a reasoning for the appeal in accordance with BZR §XV.B.1. Staff believes the comments, below, support issuing and upholding the order.

The property is in the R-15 Single-family Residential Zone, which is subject of the allowed uses and accessory uses listed in BZR §V.A. The property is developed and used as a single-family dwelling. Accessory uses in the zone do not include the keeping of animals.

Staff has received complaints regarding chickens housed on the property. The received complaint included ongoing chickens, hawks, rats being attracted due to the chickens and that carcasses were being burned on open fires. The Notice of Violation was sent in response to an initial complaint received May, 2019 and last reiterated in-office the week of March 5, 2020. I recalled the complaint. I was unable to immediately find if an NOV had been sent and determined preparing a new order, even if one had been sent without receiving response or compliance, was appropriate due to the lapsed time since the previous complaint. Research of the property card found a chicken coop listed as a structure on the property.

The applicant replied to the order and stated the owner had the chickens for some time. He indicated that they were pets. He was directed to BZR §XI.C.4.h. and XI.C.8. regarding the keeping of poultry. The Keeping of Animals section was amended several years ago. The keeping of animals, and specifically addressing poultry, would require designation as a farm and would not be allowed on hobby farms.

The order would be correct as:

- 1. As noted by the applicant, there are chickens housed at the property;
- 2. This single-family residential property improved with a house on 0.35 acre would not qualify as a farm; and,
- 3. The R-15 residential zone does not allow for keeping of animals, including poultry as an accessory use.

Therefore, the violation was correctly issued.

The Town of Berlin Plan of Conservation and Development, Section II, Strategic Outline for Implementation, Strategy 1: Coordinate the Regulatory Structure to Support the Plan, 3) states: Any variance granted by the Zoning Board of Appeals should be consistent with the standards imposed by Connecticut General Statutes in which a hardship exists owing to conditions affecting a specific parcel of land, and the variance which is granted should be consistent with the goals and policies of this plan and the intent of the zoning regulations.

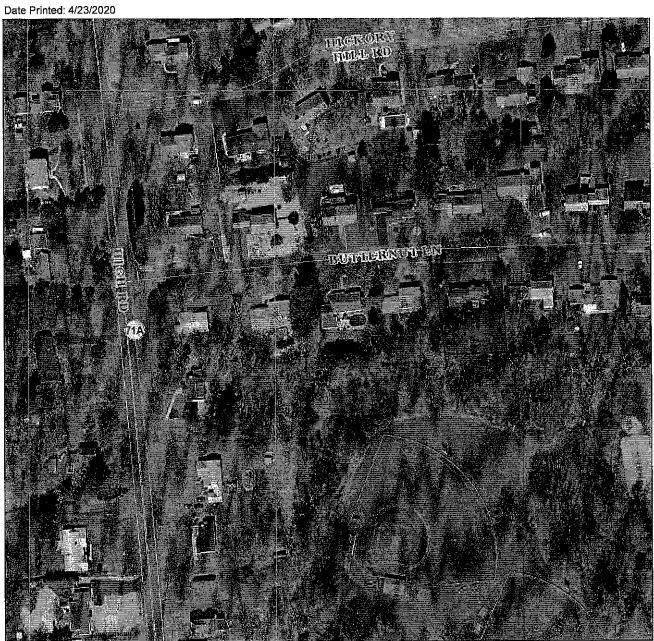

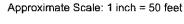

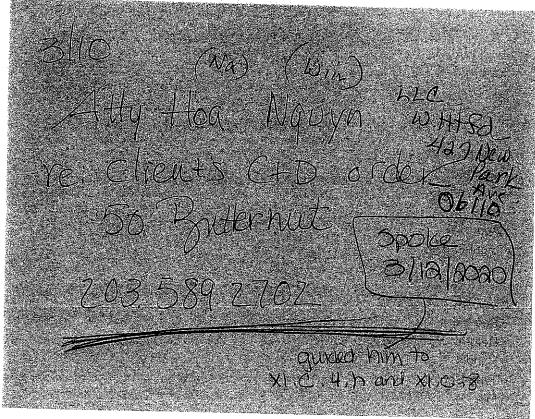
