Discussion regarding the use category for an outdoor recreation site with potential for construction of structures

PROPOSAL

Military Experience Museum, Inc. has submitted the attached description for utilizing contiguous properties to the east of the Chamberlain Highway just north of the Meriden Town line. They are looking for feedback regarding pursuing a Special Permit and site plan as a nonprofit entity for an experience camp.

STAFF COMMENTS

- 1. The use category should be identified and explained by the applicant;
- 2. How the applicant proposes to obtain site improvements for utilities (water and bathroom facilities) should be explained.
- 3. If the use is determined to fall within a category listed for the zone, it would then require Site Plan and Special Permit applications and approvals by the Planning and Zoning Commission.

EXISTING CONDITIONS

The site is accessed by a gated driveway approximately across from 2590 Chamberlain Highway. The Meriden town line runs along the southern and eastern border of the properties. Arials and Assessor's records show wooded unimproved properties with access drives and hiking trails.

Zoning Analysis

The MR-1 zone allows for special permit uses as allowed in BZR §V. Single-family residential zones (R-86, R-43, R-21 & R-15). The applicant should explain to the satisfaction of the Commission, into which zoning use category the proposed use would fit, and if the specific parameters for the use can be accomplished. Potential special permit categories might include; e. Camps, subject to the requirements of XI.F and f. Nonprofit civic organizations, subject to the requirements of Section XI.P. or d. Religious, charitable or eleemosynary institutions subject to XI.L.

To assist in categorizing, the applicant should address who would be utilizing the site, such as individuals or organizations, and when the property would be used: an ongoing, seasonal or special event basis. Proposed improvements to the site should be identified including facilities for water and sewage disposal and anticipated parking demand.

- staff plus one space for every 15 day campers. Parking areas shall be at least 50 feet from side and rear lot lines and 50 feet from the street line, and shall be suitably screened and One off-street parking space shall be provided on the site for each member of the camp permanently improved.




MILITARY STYLE OBSTACLE COURSE

FIELD LOCATION MILITARY ERA BASES / MILITARY EXPERIENCE MUSEUM INC.



Compost toilets do not separate the solid and liquid wastes. Consequently the waste does not break down rapidly and the pathogens take longer to be devitalized. I am almost positive that the trail does go through this area. I will double-check today. One of the reasons we talked about relocating it was to move it off these parcels because they were private property and could potentially be developed... which I guess is what is being proposed.

I checked out the presentation which I found a bit intense. But with their focus on recreation and as a fellow non-profit, I wonder if we can't work together and co-exist on this property. It sounds like there might be the possibility of an overnight site for thru-hikers based on their "camp" options.

If the military history piece was fully in place, I could see that being a point of interest along the trail. Maybe a side trail takes you down into that area? Do you know if they are aware of the NET? They may view it as an asset.



Military Museum Field Experience

They want to know what will be happening in the site, when and what activities, projected volume of customers.

The field location will have activities that people can participate in.

"what will be happening in the site,... what activities,"

- Orienteering Course
- Obstacle Course
- Military simulation/ reenactment

Activities will include an Orienteering Course, which is using a compass or GPS to go to specific location on a map. The activity directly relates to how soldiers would have to go to a certain place for various reasons. Using a compass or GPS as a guide is essential part of military training. It is also part of the sport of orienteering.

The other 2 major activities on the property will be the military style obstacle course and having military simulation/ reenactment events. For the military simulation, we will allow people to use airsoft replicas that shoot a biodegradable 6mm pellet, no real firearms that shoot bullets will on used on the property.

"They want to know ..., when?"

- Plan is for year round weekends, Saturday/ Sunday (weather permitting). It is outdoor activities.
- Most likely open on holidays, especially when holiday extends weekend.
 - o Example: Memorial Day, Labor Day, Columbus Day, ect..
- Summer time hours to be determine, but current plan is to allow private party / private group rentals.
 - o Corporate Team Building, Scouting groups, World War 2 reenactors, Obstacle Course Racing teams, Orienteering clubs, etc..

"They want to know ... projected volume of customers?"

- Very difficult to determine but if we get 100 customers a day we would do well.
- Current parking area will allow for total of 90 cars using both sides of the driveway, straight in parking, spaces 10' wide.

People will be able to fill out waivers online and have option to pay online and book time frames to participate in activities. This will reduce people standing in line and interaction between employees and visitors

The Field Experience is outdoor activity, once people check in they will go out onto the 70+ acres of field experiences. There will be a staging/ check-in area, that we can put some seating like picnic tables, but we are waiting to determine based on new States and Federal CDC guidelines. It is possible no seating allowed and once they check in they need to move to the field and no large gatherings.

At this time we have no plans to serve liquor. It has not even come up in discussions, as it would be many years down the line if ever considered.
