2. Approval of Minutes

May 14, 2020

Commissioner Dellaquila moved to approve the May 14, 2020 minutes.

Seconded by Commissioner Butrimas.

Vote being 6-0. (MOTION CARRIED).

3. Consent Agenda

4. Parks & Grounds

Commissioner Dellaquila moved to approve the Banner Policy as written.

Seconded by Commissioner Legnani.

The group discussed the proposed policy and agreed that slight modifications were needed.

Vote being 0-7. (MOTION DEFEATED)

It was determined that section 8A4 should be modified to add "the Athletic Director" as a party to coordinate placement of banners prior to presenting to the Parks & Recreation Commission. Additionally, the Commission agreed that given the short timing this season, Berlin High School sports will be allowed to present their proposed banner placements to Parks & Recreation Commission at the August 13, 2020 meeting. (The Policy calls for July presentation for fall sports going forward.)

Commissioner Pulcini moved to approve the amended Banner Policy (adding "the Athletic Director" in section 8A4, and allowing BHS sports to present their proposed banner placement at the August 13, 2020 meeting) subject to approval by Corporation Counsel.

Seconded by Commissioner Legnani.

Vote being 7-0. (MOTION CARRIED)

- c. Sage 1 Bids are due back on Thursday, July 7, 2020.
- d. Fields Update Director Ochoa reported that Town fields are planned to open on June 17, 2020 in accordance with State guidelines. The main contacts of user groups are being required to read and sign a Field Use Addendum assuming responsibility to comply with all Federal, State and local guidelines for COVID-19. Director Ochoa also stated that the Town was able to secure a low interest rate at its recent bond sale, and there may be additional funds to improve Sage bathrooms and Percival Soccer Field. Any residual funds thereafter will likely be directed to Garrity and Pulcini. Chairwoman Bovee noted that there is still a need for a turf field for youth football and the Commission will need financial help from organizations that have funds available to them.

5. Parks and Recreation

- a. Monthly Report See attached.
- b. Summer Update Superintendent Dennis has been advised by the Central Connecticut Health District against any in-person activities and has coordinated several online summer activity sessions. After coordinating with providers, Superintendent Dennis was comfortable scheduling in-person tennis, dog training and modeling / fashion activities that will comply with safety guidelines.

Director Ochoa noted that the initial decision to close Town pools was made on May 22, 2020 under advice of the Central Connecticut Health District and in conjunction with Town Manager Jayawickrema and Town Council. Now that restrictions around the country are loosening, residents are asking that the decision be reconsidered. Director Ochoa and Superintendent Dennis noted that it may be possible to open Percival Pool, but there will be at least 2-3 weeks of work, training and coordination needed before the facility could be opened. Additionally, securing staff on such short notice will be challenging. They will investigate the matter further.

Chairwoman Bovee encouraged Commissioners to suggest other activities that might be offered to residents, including scheduling Food Trucks at local parks.

- c. Community/Senior Center Update The architect will present Public Building Commission with its estimation of required square footage of the facility.
- d. Timberlin 50th Anniversary Update The celebration has been postponed until July 2021.

Recreation June monthly report

- 1. Emailed people who applied for summer jobs that we were not interviewing or hiring this summer.
- 2. Canceled building use from the Board of Education since we would not be offering in-person Skyhawks programs.
- 3. Worked with Skyhawks and Personal Euphoria to switch from in-person to virtual classes.
- 4. Worked with tennis to make changes to be able to still offer in-person classes. Reduced class sizes to accommodate this. Notified Board of Education of our need to use the outside bathrooms at BHS and that they needed to be cleaned daily.
- 5. We will be offering Modeling & Fashion Camp at the JC Models of Connecticut building in Rocky Hill and they will follow the guidelines that the OEC issued for running a camp.
- 6. We will be offering Dog Obedience classes at Pistol Creek. We felt it was low risk since the participants are adults and they are only there for one hour.
- 7. Met with the architect about the Community/Senior Center to give input on new facility.
- 8. Numerous discussions, emails between Newington, Wethersfield and Rocky Hill about summer programming and pools.
- 9. Worked with current staff to offer their classes virtually. We will have two painting classes Advanced Painting w/Peggy and Painting w/Peggy and three other camps Mini Art and Arts Discovery Camp, Superheroes, Pirates and Mermaids Oh My Camp and Fairy Tale Camp.
- 10. Discussions and emails with Newington to offer a joint virtual summer camp. They will take the lead with the program and we will advertise it and I will have staff who will coordinate things for Berlin, if any of our residents sign up.
- 11. Met with the Town Manager to discuss the summer and express our opinion, based on information we had received from CDC, Governor's office, OEC, Department of Public Health and Central CT Health District. Information received as of May 21. He wanted to run the information by some of the Council members before getting back to us.
- 12. After hearing back from the Town Manager on May 22, notified summer staff we would not be running any programs or opening pools and they unfortunately did not have a summer job with us.
- 13. Needed to completely update the summer brochure to reflect changes that were going to be put in place.

2020-06-11 Parks & Recreation Commission Meeting

- 14. Needed to update software registration system to reflect changes and additional programs. Skyhawks went from 9 weeks of programs in person to 32 different virtual options of programs for people to sign up for.
- 15. Coordinated with Facilities Department to get sneeze guards installed in the main office so we can offer in-person registration and also bring in support staff to help with programs.
- 16. Constantly listening to webinars, conference calls and emails from other Towns as to what they are offering, what changes the Governor's office is implementing and changes from Department of Public Health. The DPH only released guidelines for opening pools on June 10 and we received them on June 11.
- 17. I will continue to look at other options for virtual programs to offer to the community.

Parks and Recreation monthly report for July

- 1. Once the Council directed us to open Percival Pool, we have been on the fast track to get everything in place. This took a tremendous amount of coordination between Parks and Recreation, Parks and Grounds and Facilities. Each Department put in a lot of effort to make sure their responsibilities were met and we could open with all the requirements that the State of CT, American Red Cross and Department of Public Health had in place. We would not have been able to get everything done on our end without the effort of Aquatics Director Chris Zagorski. He spent many hours reviewing all guidelines to make sure we trained our staff properly and safely and had all necessary information at the pool. This process was a true "team effort" and I want to thank everyone who has helped up to this point and who will continue to help while the pool is open.
- 2. Completed staff training to be able to open the pool on July 1.
- 3. Jen and Terri have been working hard to get the registration information into our software system and on WebTrac so people can register for the pool. We are reevaluating our policy for registration to allow people to sign-up multiple times per day, if there are openings and more than three times per week.
- 4. Tennis lessons have strong numbers for the first session and will begin the week of July 6.
- 5. Katie Wicander, Director of Clover Hill Summer Fun site, has developed a "Remote Summer Fun Program" this summer. She sent out a survey to last year's Summer Fun participants and we posted the survey on Facebook and has gotten some positive responses from people. The flyer for the first week is attached.
- 6. Have already begun booking rooms for the Fall, at the Community Center. I have been letting groups know that once we have guidelines in place, those will be shared with them to make sure they can follow them and still meet safely.





Presentation on Establishing Pickleball Courts

I. What is Pickleball (PB)?

- PB is a combination of tennis, racquetball, and ping pong played with a paddle and a special wiffle ball
- Its played on a court less than half the size of a tennis court
- PB is inexpensive to play with paddles costing \$30-100. Balls can last for months and cost \$3-4 each
- PB is a game of strategy and touch, not so much power, which means people of different age groups can play together, its inter-generational.

2. Who plays PB?

- People of all ages from children to those in their 90's can enjoy PB.
- It is the fastest growing sport in the country with of growth rate of 650% over the last six years
- Many colleges have introduced PB as an intramural sport, as well as some high schools. It is expected that colleges will soon sanction PB a competitive sport like tennis, soccer, lacrosse, etc.
- It is relatively easy to learn, and you don't have to be an Olympic athlete to play it.
- It is a great investment to keep 55+ year-olds active, encourage intergenerational activity and improve the health of the Berlin community.
- There are more people playing PB than tennis (I am an avid tennis player)

3. Health benefits

- PB is an excellent cardio workout, with each game lasting approximately 15-20 minutes.\
- PB is excellent to improve balance and eye hand coordination as well as flexibility and mobility
- PB is a game that is fun right away and the PB community encourages and helps newcomers

4. Court requirements

- A PB court is 20x60, which is one side of a tennis court. Two PB courts fit on one tennis court
- The PB court would have to be striped to specifications (see attached)
- Quality Portable PB nexts are available for approximately \$200 each

5. Court Options

First option would be to construct permanent dedicated PB courts.
 Cost is approximately \$20-\$30k per court

- Second option is to put two dedicated PB courts on a tennis court. Would require painting one tennis court, then re-striping for PB and installing two post on each side with permanent nets. Based on the explosive popularity of PB and the experience of other communities in CT this would be the least costly, most desirable option. This option could be accomplished less costly by not painting the tennis court, but re-striping only with permanent nets.
- A third option would be to re-stripe an existing tennis court, one court per side and utilize a portable net system. Though less costly, there is the issue of the possibility the nets can be stolen.
- 6. What have some other communities done?
 - West Hartford, Wolcott Park has constructed 6 permanent dedicated PB courts. I currently play there and the courts have been busy every day and evening.
 - Milford has 8 dedicated PB courts
 - Middletown has several PB courts
 - Cheshire has 6 dedicated PB courts
 - Fairfield has 4 dedicated PB courts
- 7. There are two certified PB instructors willing to donate their time to teach people how to play and populate the sport.

Recommendation:

I would suggest one of the variations of option 2 above depending on budget considerations. One of the tennis courts at McGee could be converted into two PB courts. I would be willing to assist in any way possible.

Good Morning Jennifer and Steve

Following is a narrative on the Kensington Garden Club (KGC) Volunteer Park Native Plants Project. It also includes an estimated cash value of the plants to be purchased. The purchases will be made by Kensington Garden Club with grant monies awarded by the Community Foundation of Greater New Britain.

SUMMARY:

Kensington Garden Club President, Paula Archacki and Past President, Kathy Ginotti met with Steve Wood in early 2020 to discuss the possibly of removing all invasive plant materials and replant with native plants in Volunteer Park. A design plan was agreed upon. The project includes a clean up of other plant material that may not work well in the plan or may not offer any value so that our end result is a native plant friendly and aesthetically pleasing park area that is central to Berlin, CT traffic and beneficial to the environment and its native birds and insects. There are two phases to the project.

<u>Phase 1</u> is to remove plant material, replant natives and rock mulch the back side of the garden close to the brick building. Phase 1 has been completed and funded by the town using allowable dollars.

<u>Phase 2</u> is to remove plant material along the Porters Pass sidewalk, replant native plants, clean edge the borders and add wood chip mulch in accordance to the agreed upon design plan. It also includes replanting in the rock garden along Farmington Ave. KGC will fund the purchase of the plant materials using grant monies awarded by the Community Foundation of Greater New Britain and the town will manage the work, with the exception of the perennial plantings in the Pollinator Garden at the corner of Farmington Ave and Porters Pass. This will be handled by KGC members. The cash value of the plant materials to be donated by KGC to the town is \$2500, max.

Project Goals

- 1. Remove the invasive Burning Bushes and Barberry Bushes (this will include other plant material that is unsightly or past their prime.) This will reduce the amount of invasive spread in our protected area forests.
- 2. Plant native Pink Dogwood trees (Cherokee Brave), Oakleaf Hydrangeas, Red Sprite Winterberries, Mountain Laurel bushes and a variety of perennial pollinator plants. The dogwoods and winterberries produce berries that will feed the birds. The dogwood is the Kensington Garden Club flower and the mountain laurel is the state flower. The other native selections are proven to do well in North America so they should be pest free, they will provide beauty and healthy pollination opportunities for the butterflies and the bees as well as a natural habitat for insects and butterflies.
- 3. The selected native plants will beautify the area. The line of dogwood trees along one garden will provide a stunning affect in the spring. The line of winterberries will provide a stunning affect in the winter showing bright red berries. The Oakleaf Hydrangea produce large white cone shaped flowers in the summer that last into fall when they turn dark pink and the leaves turn to a deep red in later fall. The mountain laurels will be place in front of utility boxes in a

- shaded area that is part of their care. The pollinator plants will be used to enhance the existing garden that was started 2 yrs ago.
- 4. Knock Out Roses will be used to replace a hodgepodge of plant material in an area with a rock dedication that is visible to foot traffic as well as vehicle traffic.
- 5. This effort takes collaboration with the town which helps us continue to build and nurture our healthy relationship in working together for the benefit of the residents of Berlin CT
- 6. This effort provides an opportunity to educate our community about the negative impacts of (non-native) invasive species and the benefits of natives. We will use the Berlin Citizen, Facebook, Federated Garden Club of CT CTNewsletter and our website to share the information; possibly other media.




