PROPOSAL

The applicant is requesting Special Permit approval to locate a fast food business use for Paradise Nutrition at 1244 Farmington Avenue Unit 3 pursuant to §VI.I.3.c. of the Berlin Zoning Regulations.

STAFF COMMENTS

- Any increase to seating is subject to staff zoning review.
- 2. Signage requires application for building permits with zoning review for compliance with BZR §IX.A and the Farmington Avenue Design Standards.
- 3. Interdepartmental staff comments be address to the satisfaction of the department.

BACKGROUND / EXISTING CONDITIONS

The 0.71 acre site, known as Anchor Plaza, contains an existing approximately 4000 s.f. commercial building which was constructed in 1960. Parking is provided on site. In recent years there has been some turnover of uses and vacancies in the existing multi-tenant building. Mixed commercial uses include retail food, personal service and professional offices. The last known tenant for this unit is unknown. No changes to existing site conditions at the established plaza are proposed.

ZONING/ parking

The described nutrition shake shop is by definition fast food. The applicant proposes 12 seats for the primarily take-out use. Fast food uses have a requirement of 1:75 s.f. parking. And would require 11 spaces. Zoning records indicate there is adequate parking with approximately 50 parking spaces on site.

Department Comments:

Central Connecticut Health District provided a plan review noted as approved with conditions which would be required to be accomplished prior to their sign off on opening. (attached)

The Central Connecticut Health District (CCHD) has reviewed the floor plan which was received on 9/22/20, menu and equipment specifications for the above referenced facility. Based on my review the plan is approved with the following conditions:

- 1. Proposed plans must be submitted for review and approval by other departments. All applicable permits shall be issued prior to start of work.
- 2. Consult with the Berlin Fire Marshal regarding the hood system.
- 3. Consult with the Worthington Fire District regarding the possibility of installing a grease trap unit. (860-828-5630)
- 4. Based on the submitted menu, your license classification will be a two (2). A class two establishment means a retail food establishment that does not serve a population that is highly susceptible to foodborne illnesses and offers a limited menu of food that is prepared, cooked and served immediately, or that prepares and cooks food that is time or temperature controlled for safety and may require hot or cold holding, but that does not involve cooling. A Certified Food Protection Manger (CFPM) is required. The CFPM must successfully complete a food manager's exam at one the of approved CT testing organizations. The CFPM shall work at least 30 hours a week in a supervisory position. A Person in Charge (PIC) is required whenever the CFPM is not available. The PIC will also need to complete a food safety manager's exam at one of the approved CT testing organizations.
- 5. The baking of pastries is not permitted at this facility. Pastries maybe purchased commercially and held within this facility.
- 6. Waffle batter maybe prepared by using water from dispensing unit and cooked in the waffle iron with the addition of cut of fresh fruit and whipped cream.
- 7. The shared dumpster must be large enough to accommodate your trash. The lid shall stay closed when not in use.
- 8. The kitchen hand sink must have hot water at minimum of 110F, dispensed soap, dispensed paper towels, and a trash receptacle.
- 9. The three-bay sink shall have compartments large enough to completely submerge your largest piece of equipment. Hot water supplied to the three-bay sink should be no less than 120 F. A wire rack shall be installed above the 3-bay sink for the storage of wet utensils to drip dry.
- 10. Wall material behind all sinks and toilet shall be a non-absorbent material.
- 11. Cove strip molding is required at wall to floor junctures.
- 12. Fresh fruit maybe washed in one of the 3-bay sinks when not in use.

- 13. All equipment and storage shall maintain a 6" gap above the floor.
- 14. Supply a covered bin or drawer for clean food utensils.
- 15. The floor base mop sink shall have hangers installed above the sink drain for damp mop heads to drip dry when not in use. The sink shall have no gaps to wall and floor. The wall material shall be non-absorbent. It is suggested to store toxic chemicals and cleaners near the mop sink.
- 16. Must have sanitizer testing strips on site. Sanitizer buckets/ spray bottles shall be labeled accordingly.
- 17. Employees shall have an area to store their personal belongings.
- 18. The unisex employee/public restroom shall have hot water not to exceed 115 F. A covered trash receptable is required. Post a sign in restroom stating, "Employees must wash hands after restroom".
- 19. A final inspection shall be conducted prior to opening. All dust generating material shall not be in the building during the inspection.


