II. MTB Race at Hatchery Brook – Brian Wolfe reported that the race will take place Sunday June 6, 2020 8:00 am to -3:00 pm with a set up time at 6:00 am. There will be about 75 participants. Parking will be on Linden and Summit Wood Drive. They will notify residents. The course map is similar to the last race. Commissioner Lewis stated that the group did a great last job at the last race. Vice Chairman Hoffman reported that there are a couple spots on the course that could get messy if there is rain. The group has a done a good job fixing these areas up in the past. The only foreseen issue is if the town

Covid-19 restrictions. The police will need to be involved in the race as well as parking. The group will cancel if there is more than an inch of rain per their own guidelines. Mr. Wolfe also would like to walk the course with a commission member with social distancing prior to the race. The group would also be dropping off Porto Potty's the Friday prior and being picked up the Monday after the race with social distancing guidelines. The group will be posting signs on all ends of the race areas.
