Recreation May monthly report

- 1. Sent out paperwork for summer staff, new and returning. Have 27 new staff.
- 2. Contacted Hunter's Ambulance to set up first aid and cpr classes for the Summer Fun program staff.
- 3. Working on entering new staff and will email all staff about blood borne pathogens program through CIRMA and Sexual Harassment link, as required by the State of CT. Still need to set-up Mandated Reporter training for the Summer Fun staff.
- 4. Opening and closing p.o.'s for the end of the fiscal year.
- 5. Fishing derbies were held, nice turn out for both days.
- 6. Decided not to do a full brochure this year but instead just do flyers for each program. Most programs will start registration for residents on May 17 and non-residents, where allowed, on May 24. Swim lesson information will not be out until sometime in late June.
- 7. On-line registration for the Summer Fun program started on May 10, with few issues. Both sites have spots open.
- 8. Started ordering supplies for Summer Fun program and Aquatics.
- 9. Worked on developing policies for the Summer Fun program and Aquatics, based on current guidelines and recommendations. Aquatics is similar to last year, with a few changes. Note that even though the State is looking to open up things on May 19, they have sent out specific guidelines for pools and summer camps that we need to follow. I will continue to monitor all sites, CDC, OEC, DPH and will adjust things if changes are made.

Replacement of the deteriorating board located next to the small parking lot at Pistol Creek. Will provide a map to label distances and features of the open space. Board will also provide a place for lost items and community postings.

My name is Robyn Cop and I am writing this letter on behalf of my family as well as the T Cop Foundation. We are seeking approval for the dedication and naming of the basketball courts at the Berlin High School to be named after our son Tyler Cop. We unfortunately lost Tyler unexpectedly at the age of 15 years old.

We would like the basketball courts named after Tyler. Tyler was big into his community and had a huge impact on Berlin community/athletics for his short life. He was always striving to make Berlin a better place. Anyone who knew Tyler in Berlin, knew his love for especially basketball, but overall athletics. He played Park and Rec basketball for 8-9 years, assisting in helping the program as needed by helping in practices, educating any youth in any sport, organized pick up games at local courts and played on the Berlin High School basketball team.

After Tyler had passed, we wondered how we could memorialize his memory in our community to what he loved. Everyone in town, his peers, friends and family wanted to help update the basketball and tennis courts at the high school. We met with Jack Healy, the town manager at the time and started to see how we could help. We had multiple meetings and made it a reality. The T. Cop Foundation stepped up and donated money to assist in the renovation of the basketball and tennis courts. We have given significant contributions to this community by donating money to assist in the completion of basketball/tennis court project, landscaped around courts, had plantings donated and planted in conjunction with public grounds department. We also hold a largely followed basketball tournament annually at these basketball courts to honor Tyler.

The Cop family has been an integral contributor to the community/as well as Park and Recreation programs. Whether it be looking at new projects to assist the town in, coaching, or volunteering time the Cop's are always involved. We have coached for many years with the Park and Recreation basketball program from teaching first and second graders instructional basketball skills, to coaching until eighth grade where they would be entering the high school programs. We have also contributed greatly to other programs and coached soccer, baseball, softball, football programs. Any program that needed volunteers or help the Cop's would step up and donate their time.

In closing, through this terrible life event of loosing Tyler, we would like to honor him and his short life by naming this court. He had a huge impact on his peers, coaches, friends, family and quite frankly anyone he met. His impact goes unforgotten with dedications in every school he attended. His impact on this town will be remembered through his dedication and skill in his athletics, growing and mentoring in the park and recreation activities he performed and more importantly the amount of Berlin people he touched.. The T. Cop Foundation continues to be successful and will continue to pair with the town as needed to better athletic and community programs.



June monthly report

- Processing paperwork for summer staff, new and returning, almost 50 people. Had one of the
 experienced lifeguards quit, that will impact schedules. Aquatics Director notified me that he
 has another full-time job and will only be able to work a limited number of hours. He did
 conduct staff training and completed work schedules but will not be around for a lot of the day
 to day responsibilities.
- 2. Set up first aid and cpr classes for the Summer Fun program staff, through Hunter's Ambulance. Also set-up Sexual Harassment training and blood borne pathogens, which are required for all staff.
- 3. Getting equipment ready and bringing out to the pools for inspection, Percival on June 4 and Demore, Dinda, Bittner Jr Memorial on June 17. Worked on aquatic staff manual and prepared for staff meeting and in-service that was held Saturday, June 5. Percival set to open June 19 and Demore, Dinda, Bittner Jr. Memorial on June 21, for the season.
- 4. Worked on Summer Fun staff manual. Each site will coordinate their own training this year, on Thursday, June 17.
- 5. Ordered supplies, bathing suits for guards and staff t-shirts for all staff.
- 6. Opening and closing p.o.'s for the end of the fiscal year and going through supplies to order what is necessary to start the pools and summer programs.
- 7. Arranged for phones at pools to be turned on and cell phones for emergencies.
- 8. State DPH decided on May 20 that all restrictions on the pools would be lifted. We had to immediately start preparing to sell pool passes. Clover Hill and The Creek are starting to fill up some weeks.
- 9. Covered office, handled daily registration while secretary took vacation time.

Policy on Memorials and Naming Facilities/Fields

I. Purpose of the Policy

The Parks and Recreation Commission recognize that individuals and groups may desire to recognize a friend, family member, volunteer or employee after years of service to the community. Request for recognition will be honored if the Parks and Recreation Commission recognize a benefit to the specific park/location under its jurisdiction.

II. Responsibilities

The Commission will recommend the naming of playscapes, rooms, structures, fields, parks or other memorial items. It will also recommend benches, picnic tables or trees with memorial plaques/name plates. The design and location of such memorials must be approved by the Parks and Recreation Commission prior to recommendation to Town Council.

All costs and the collection of money will be assumed by the individuals or groups that request the memorial.

The Commission will make the recommendation to the Town Council and the person or persons initiating the request should plan on attending the Town Council meeting to answer any questions that may arise.

III. Guidelines

The naming of structures, parks, fields, etc., will be for individuals who have had an impact on parks, recreation or athletics in Berlin. The priority in the approval process will be to individuals who have volunteered for the Parks and Recreation Department or made significant contributions to the community.

IV. Procedure

- 1. Submit a request in writing to the Parks and Recreation Commission.
- 2. A written response will be sent after the Commission's decision.
