Madam Chair, Mr. Vice Chair, and Members of the Commission:

I am writing to you to propose an official name for an unnamed or to-be-built baseball field or complex in town.

My father, Jim Marturano, has spent nearly his entire life involved in the Berlin youth athletic programs, and specifically baseball and football. Growing up in Berlin, he played on the sports teams in the town. Continuing to live in Berlin, he has umpired little league for well over twenty years, and has been the Umpire-In-Chief for many of those years. He has coordinated and trained teens and pre-teens in the town to umpire little league games for as long as I can remember. The lives of children in the town of Berlin he has impacted are countless. Not only as a coach for Berlin's Little League and Babe Ruth leagues - my coach for many of those years, but as a inspirational figure to all of those kids that wanted to just be called "Blue" and earn the respect of adult coaches and players alike.

While naming a field after a person who is still alive can be controversial, my father deserves this honor for the legacy he has already built in training up the Berlin youth, and will continue to do so until his body no longer allows him to. He has dedicated decades of his life to Berlin athletics and training up our leaders of tomorrow. The impact he has had on the town cannot go unnoticed, and in fact, should be honored. An honor that has yet to be bestowed on him. I believe the honor of having a field bear his name would cement his legacy on the town in history. My father has touched the lives of every single little league baseball and softball player that has come through this town in the last quarter-century and more, whether they were aware of it or not.

My words are not enough to describe the impact he has had on the town, but the fruits of his labor are apparent whenever a kid takes to the mound for the first time, or steps into the batter's box for the first time, as the person standing behind the catcher was inevitably trained up by my father to be fair, just, patient, and kind to all those who step onto the baseball field.

As a little league coach, Umpire, Umpire-in-Chief, in Berlin for a couple of decades now, I feel this honor is deserving of Jim.

Jim has always been dedicated to sports and athletics in Berlin. Starting as a youngster himself playing ball here in Berlin under the coaching and direction of his own Dad, Frank Marturano.

He had then, and he still does, a passion for sports. Not only playing himself, but then teaching, coaching, and training countless other young boys and young men to have their own appreciation of sports in Berlin.

Jim always put the children first. Allowing each one to have field time and to play, even if they weren't considered the "stars" of the day. And even against sometimes contrary opinions or strategies. He always felt each child should be given the opportunity to play, adjust and improve.

Jim's dedication to the Little League program in Berlin is un-matched. He is also honorable and hard to beat. As Jim's wife for many years, I can remember the long hours spent on making schedules, making phone calls, collecting schedules, coordinating players, umpires, and games, etc.

He sometimes would fall asleep with the schedules on his lap.

In addition to all that, he also spent hours coaching and umpiring, training, and encouraging other youngsters to step up to the plate, as it were, and learn umpiring, earning valuable life skills, sportsmanship, responsibility, fairness, and a consistent work ethic. Jim leads by example, instilling good values, teaching the rules of the game and inspiring a love for sports and athletics. Many children have looked up to Jim for his patience, kindness, levelheadedness and encouragement.

Jim deserves to be honored and I'm sure the kids he had under his wing for the past 2 decades would agree.

Chairwoman Bovee called the meeting to order at 6:00 p.m.

#### 1. Audience of Citizens

a. Robyn Cop, 65 Division Street – Ms. Cop appeared to support the request to name the outdoor basketball courts at Berlin High School after her late son, Tyler Cop. Ms. Cop stated that Tyler was a community-minded young man and the Cop family and T. Cop Foundation continue to enhance Berlin in his honor. In addition to the family's ongoing volunteerism, the T. Cop Foundation contributed financially toward the recent basketball court renovations, as well as many toward other improvements in Berlin. (Director Ochoa added that if the Parks & Recreation Commission approves the request, it will move on to Board of Education, Planning and Zoning and eventually Town Council for further consideration.).

# (Commissioner Starr arrived at this point.)

- b. Connor Yorski, Eagle Scout Project- Mr. Yorski proposed to replace the sign at Pistol Creek located by the handicapped parking lot. He proposes a professionally rendered map of the walking trails, a corkboard for community postings and a lost-and-found box mounted on pressure-treated wood, covered with a shingled roof to protect users from sun and rain. Mr. Yorski will ask local businesses for materials and monetary donations and will contribute any shortfall himself. (The Commission noted that the diagram may be subject to change if an off-leash dog area is established at Pistol Creek.) The project estimate is \$650-\$850 and Mr. Yorski proposes to perform the work early Summer 2021.
- c. John Dumin, 183 Grandview Avenue Mr. Dumin appeared to support the Berlin Volunteer Fire Department's application to host a family picnic (estimated 80-100

guests) at Pistol Creek on August 29, 2021. BVFD proposes to serve alcohol and Police Chief Klett has approved the request.

- c. Pistol Creek proposed dog park The Town Council Ordinance Committee is considering the fairway located on an inner-loop of Pistol Creek as an off-leash dog area. The area is being considered due to the ample parking at Pistol Creek, its distance from neighboring homes and its insulation from the "outer loop" of the walking trails, so that walking trail users would not have to encounter the off-leash area if they choose to avoid it. The Commissioners discussed possible conflicts with an off-leash area on the fairway, including: 1) its proximity to the clubhouse and children who participate in indoor/outdoor camp activities there; 2) possible wetlands restrictions; 3) interference with BHS Cross-Country's use of Pistol Creek. The proposed fairway is used as an infield for warm-up and stretching by the athletes.

As required by the Parks & Rec Commission's Banner & Sign Policy, this letter is to request permission, on behalf of the BHS Athletic Booster Association, Inc. for the following teams to hang banners on the fences at Scalise Field, Sage Park.

- 1. Hang four (4), 40" tall x 30' long windscreen banners on the visitor's side of Scalise Field, two on each end, beginning at the 30-yard line going to the goal line. See exhibit 1.
- 2. Hang two (2) banners, approximately 40" x 40", vinyl banners on the fence at the end zone in front of the fan picnic table area. Memorial banners. See exhibit 2.
- 3. Hang two (2) banners, 40" tall x 8' long, vinyl banners on the fence, entrance to Scalise Field fence, facing the field. Sponsor banners. See exhibits 3 & 4.

4. Hang one (1) banner, approximately 40" x 40", vinyl banner on the fence separating Scalise Field and the upper soccer field, nearest to the concession stand. Class Act School Banner.

All banners will be secured to the fence with either plastic zip ties or tennis clips.

Banners will be hung up at the beginning of the Fall Sports Season, no later than August 31, 2021, and removed at the end of the Fall Sports Season, but no later than December 15, 2021. The four (4) windscreen team banners will be reinstalled for the start of Spring Sports Season but no later than March 15, 2022, and removed at the end of the Spring Sports Season but no later than June 20, 2022.

The six (6) team representatives have met, along with BHS Athletic Director, Dave Francalangia, discussed and agreed to the banners and the placement of the banners. See attached letter of approval from Dave Francalangia.



From: Parks and Recreation Commission

As you consider different locations for a dog park, we offer the following points for your consideration of the Pistol Creek site.

- a. Parking is available across the street from the field being considered. There are a few handicap parking spots on the same side as the field being considered. If you decide that the Pistol Creek site is the location of a dog park, we ask that you require all pets on a leash when walking from the parking lot or handicap spots until the owner arrives at the dog park defined. To protect:
  - i. walkers and
  - ii. children and families that attend the Parks & Recreation summer camp for children that operates in the building and the back deck and field.
  - iii. Anyone renting the facility.
- b. McGee and Berlin High Cross Country teams currently run their meets at Pistol Creek and use the field you have identified as a gathering place. Prior to any decision the teams and coaches should be contacted and allowed to provide commentary.
- c. Pistol Creek is used and enjoyed by many walkers. We believe that is the best use of this open space and the walkers should be the #1 priority in any field at Pistol Creek being proposed. It is our strong/unanimous opinion that any dog park at Pistol Creek should be fenced in preventing unleashed dogs from roaming into other areas and into the wetlands.
