#### 3. Consent Agenda

#### 4. Parks & Grounds

a. Monthly Report – see attached

The group discussed recent social media comments about issues at the Micacci memorial at Deming Park and Friendship Place. Unfortunately, residents did not

report the problems they witnessed to the Town, rather they posted to social media. Once Grounds staff was aware, the problems were investigated and addressed. Members discussed posting signs at Town parks with a phone number for residents to call to report any issues.

Commissioner Pulcini joined at this point.

#### b. Revision of Policy on Naming Memorials, etc.

- **i.** BHS Basketball Courts renaming update Director Ochoa does not believe that the Cop family has presented to the Board of Education yet.
- ii. McGee Baseball Field renaming update

The Commission will consider proposed revisions to the Policy on Naming Memorials. Commissioners discussed adding a clause that the person proposed to name the park after should be someone with good moral character, instituting a waiting period prior to approval in case the public wants to weigh in on the proposed naming, whether Parks & Recreation Commission should / can investigate naming candidates and having the Town / Corporation Counsel review any proposed revisions prior to presenting to Town Council.

- c. Percival Soccer Field Update \$194,000 of the grant has not been appropriated. Director Ochoa and Superintendent Wood will review project needs to go out to bid for a new architect and work to get \$194,000 added to the project budget.
- d. Sage Park Restrooms Update Director Ochoa reported that the restroom renovation that was originally scheduled to be completed on 9/12/21 has been significantly delayed due to unavailability of fixtures and doors. The new target completion date is end of October 2021. The delay is a problem for busy Sage Park during fall season. Porta-potties are on site to serve as temporary restrooms. The restroom delay along with a refrigeration problem that negatively impacted fund raising concessions on Friday 9/3/21, Saturday 9/4/21 and Sunday 9/5/21 were not timely communicated to Director Ochoa or the Commissioners. Commission members request improved communication/coordination from Facilities to Parks & Recreation regarding active projects.
- e. State of CT Grant Update No updates, still waiting for State feedback.

- b. Community/Senior Center Update Chairwoman Bovee reported that the Community Senior Center Advisory Committee met on September 2, 2021. Townwide Refund Policy: Except where departments institute more restrictive policies, there will be a townwide refund processing fee of 10% of the original fee paid. The minimum processing fee will be \$5.00 and the maximum fee will be \$50.00. This fee will not apply if related to a Program that has been canceled by the Town, in a situation in which the fee was charged in error by the Town or in the case of tax refunds.

No refunds will be provided in instances where the Town has purchased items or services and those items or services cannot be refunded. Individual departments of the Town may institute more restrictive refund policies provided those policies are communicated to users at the time of purchase.

Refunds provided in accordance with the townwide policy listed above, and with all necessary approvals of any commission with responsibility over impacted department, shall not require approval of the Town Council or Board of Finance prior to execution.

Per Sec. 3-31(b) of the Town Charter, "an owner reclaiming an impounded animal shall pay a fee, as determined by the town council and listed in the town fee schedule, for impoundment, plus any advertising costs, plus board for each day the animal is impounded, plus veterinary costs incurred by the town." The Berlin Animal Control Officer shall have the authority to waive the fees listed in Sec. 3-31(b) of the Town Charter with approval of the Town Manager.

# Parks and Recreation monthly report for October


- 1. Fall programs are ongoing, we added a couple dance classes.
- 2. Winter basketball registration started October 4. Registration is average with 68 registered as of Tuesday, October 12. Per current guidelines from the State, all participants, players and coaches, will be required to wear a mask while in the schools. We have not heard if spectators will be allowed but if they are, they will also need to wear masks.
- 3. I have contacted staff from 2 years ago, to see who is not returning to determine number of new staff to hire. I am anticipating many new staff will need to be hired. I will post on the Town website, Facebook page and announcements will be made at BHS. Bob Veronesi will continue as the boys 3&4 coordinator and Kaitlin Starr with be the boys 5-8 coordinator. I am currently looking for a girls coordinator.
- 4. Scarecrow Contest this year will be a run the same as last year. We have teamed up with Chris Edge and local businesses to help encourage people to put scarecrows in front of their house and business or at Volunteer Park. Participants can send in a picture and people can vote on Facebook for the Berlin Best Scarecrow, starting October 20 through October 29.

We will also do the Pumpkin Decorating contest on-line. Participants can send in a picture of their pumpkin and we will post of Facebook for people to vote for their favorite so we can continue with our "People's Choice" contest. Everyone that enters will receive a small gift.

We are doing a drive-thru Trunk or Treat event at Sage Park on Saturday, October 23, from 6-7:30 p.m. People must register ahead of time and we will have people handing out candy at their "trunk". Participants will drive through the event, to limit exposure.

- 5. Started to work on the Tinsel Fun Run and registration will begin shortly. Race will be held at Berlin High School on Saturday, December 4.
- 6. Community Center has slowly continued to have groups come back. People have been good about wearing masks while in the building.
