#### 1. Fee Waiver Policy

- 1. Fee waivers will be granted on an ad-hoc basis giving due consideration to the financial needs of the Town and the fiscal impact of the waiver upon the Town.
- 2. Chapter 5-5 of the Town Charter states that the Manager cannot, without the Council approval, purchase or contract to purchase if such action involves an expenditure of ten thousand (\$10,000.00) dollars or more unless otherwise provided under state law or regulation and with respect to any purchase of ten thousand (\$10,000.00) dollars or more, the Manager shall invite sealed bids or proposals.

On December 8, 2022, the Ordinance Committee voted to recommend to the Town Council to adopt an Ordinance to increase the bid threshold for the purchase of goods and services to \$25,000, define the criteria for bid waivers and the use of State of Connecticut or Public Consortia, and schedule a Public Hearing as required by Section 3-8 of the Town Charter. The foregoing are permitted to be adopted via Ordinance pursuant to Connecticut General Statutes section 7-148v.

A Public Hearing was held on Tuesday, January 3, 2023, at 7:00 PM in the Town Council Chamber for the purpose of receiving both written and oral comments concerning the bid threshold amount.

## Sec. 16-256 Bid Threshold for the Purchase of Goods and Services, Criteria for Bid Waivers, and the use of State of Connecticut or Public Purchasing Consortia

The Town Manager shall execute and oversee all purchases made by the Town or by any board or commission or agent thereof, except as may be specifically provided otherwise in the Town Charter. In executing and overseeing such purchases:

- (a) The Town Manager shall not, without the prior approval of the Town Council, purchase or contract to purchase if such action involves an expenditure of twenty-five thousand (\$25,000.00) dollars or more unless otherwise provided under state law or regulation.
- (b) With respect to any purchase of twenty-five thousand (\$25,000.00) dollars or more, the Town Manager shall invite sealed bids or proposals, giving at least ten (10) days public notice thereof by publication in the form of a legal advertisement appearing in a newspaper having substantial circulation in Berlin.
- (c) The Town Manager, with Council approval, may waive the requirement for sealed bids if it is deemed to be in the best interest of the Town. The Manager, with Council approval, shall award said purchase or contract to the lowest responsive responsible qualified bidder thereon, or shall reject all bids or proposals. The requirements of this subsection may be waived to the extent permitted by Connecticut law with the approval of the Town Council.
- (d) Pursuant to Conn. Gen. Stat. section 7-148v, the Town Manager may authorize the purchase of equipment, supplies, materials or services from a person or entity who has a contract to sell such goods or services to the State of Connecticut, other state governments, political subdivisions of the State of Connecticut, nonprofit organizations or public purchasing consortia available through a regional educational service center or regional council of governments, in accordance with the provisions of such contract.

#### **SUMMARY:**

- The Town's current labor attorney, Duncan Forsyth from Halloran Sage, LLC does not specialize in pension plan documents. There are also no current attorneys within the Halloran Sage, LLC law firm that specialize in pension plan documents. This is not that uncommon given that most municipalities have completely removed defined benefit plans from their retirement packages.
- The Town was provided with a few different options from Duncan Forsyth, one of which was vetted, providing a ballpark quote of \$15,000 \$25,000.
- The Human Resources Director also reached out to a well-respected HR professional and was given the name Douglas Lamonte from Berchem Moses. He was vetted and ultimately seems to be the best fit. Attorney Lamonte is a partner with Berchem Moses, has been with the firm since 1991 and currently advises clients regarding their qualified retirement plans. Attorney Lamonte utilizes plan document software called Relius which is considered to be one of the most trusted names in document solutions. Relius is an IRS-approved Mass Submitter, that provides complete pre-approved plan services.

**SUBJECT:** Townwide Rental and Service of Uniforms

#### Summary of Agenda Item:

The Town has engaged with UniFirst Uniform Services for over 10 years for the service and rental of uniforms. Currently eight Town departments utilize this arrangement including: Senior Center, Timberlin, Facilities, Animal Control, Garage, Public Grounds, Water Control, and Highway.

During the summer and fall of 2022, the Purchasing Agent worked with managers from the various departments to determine current needs, concerns, and ideas about uniform rental, and developed a Request for Proposals. We first bid RFP #2022-28 and then it was re-bid #2023-09. Both were advertised in the Hartford Courant and publicly opened and recorded on June 23, 2022, and October 27, 2022, respectively. Bidders were provided with a current inventory and asked to submit a proposal that would maintain current employee needs/expectations, while providing flexibility in customer service and efficient/reliable billing, among other tasks.

The Town received 1 proposal from Unifirst the first time we went out to bid. When we re-bid, the Town received 3 proposals: Unifirst Corporation of Indian Orchard, MA, Cintas of Mason, OH, and White Way Laundry of Wallingford, CT.

It will ultimately be the responsibility of each of the departments individually to determine actual inventory needs and service levels. A single Purchase Order will be prepared in Finance on an annual basis. Funding will come from established line-item accounts within the various departments' operating budget each year. It is important to note that as a result of this format, the costs presented in the proposal are not guaranteed as a final contract amount; rather they were intended as a best effort means to line up with the cost of current inventory and service.

Note: Some of the Town departments (Senior Center and Animal Control) may buy their shirts outright so the annual cost above may end up being less.

Finance plans to centralize billing and managing the payments to eliminate invoicing issues we have had in the past. The Town Purchasing Agent will take care of uniform invoicing going forward.

SUBJECT: Donation of Used Generac 130 KW Generator to Berlin Housing

Authority

### Summary of Agenda Item:

In 2022, a request from the Berlin Housing Authority was made to the Town of Berlin for assistance with funding the purchase and installation of a standby generator to be installed at no. 31 and no. 33 Colonial Drive which serves elderly housing and the Senior Center. The building is owned by the Berlin Housing Authority with an agreement for the Town of Berlin to occupy a portion of the building for use as a senior center. Through conversations, a request was made to determine if a used generator in possession of the Town, which previously served Berlin High School prior to the renovation, could be utilized at the Berlin Housing Authority Building on Colonial Drive.

Preliminary criteria were established, and it was determined that the 130KW Generac diesel stationary generator in the Town's possession may be adequate to serve the building on Colonial Drive. The cost of testing and commissioning the Town's generator was substantially lower when compared to quotes received by the Berlin Housing Authority from generator installation firms. The Town contracted with the previous authorized factory service provider Huntington Power Equipment of Shelton, Connecticut to service and test the existing generator to determine the condition of the equipment after being removed from service at the High school and sitting in storage over five years. All service was performed, and a load test was completed with documentation to allow for discussion on the next steps. The Housing Authority has agreed to accept the donation of the generator with documentation of working condition. To install the generator at the Colonial Drive building, additional electrical design, wiring, sitework, components and coordination with EVERSOURCE will be needed. The funding, responsibility, ownership, and implementations of the next phases needs to be discussed, reviewed, and approved between parties. The formal approval of the generator donation from the Town of Berlin to the Berlin Housing Authority will initiate the next steps and continue to move the project forward.

#### **Action Needed:**

Move to approve the donation of one Generac 130 KW diesel standby generator with the model number 99A-06077-S and serial number 2051176 to the Berlin Housing Authority for use at number 31 and 33 Colonial Drive.

I was able to research the records and am attaching copies of the following documents that pertain to the Senior Center usage of the property at 33 Colonial Drive, Kensington:

- Executive Board Minutes March 7, 1983 with paragraph highlighted referencing the Agreement between the Housing Authority of Berlin and the Town of Berlin to use a portion of the property as a Senior Center.
- Agreement, dated January 31, 1983 which included paragraphs 2 and 7 as referenced in the Executive Board Meeting. Paragraph 9 states the Town has a right to construct an addition and Paragraph 10 states that the agreement shall run for 99 years. This document was filed with the Town Clerk's Office on March 17, 1983, Volume 228, Pages 934-936.

The issue of "not less than 25 years" was language required on the Cooperation Agreement with the State of CT and the Berlin Housing Authority in order to apply for funds to build Percival Heights and the Senior Center.

Hope this is helpful. I will keep a copy as well at the Senior Center with our paperwork on the building and the expansion study.



#### MINUTES

#### Executive Board March 7, 1983

The meeting was called to order at 7:30 P.M. by Mayor Thomas W. Ward, Jr. Deputy Mayors William F. McKeon and Robert A. Argazzi were present. Also present: Mrs. Barbara Geary, Economic Development Director; William Diskin, Chairman Economic Development Commission

Mrs. Geary explained she requested proposals from seven fee appraisers and/or marketability consultants in Connecticut; five replies were received. (see minutes of December 13, 1982) She recommends the low bidder, The Hannon Company of Goshen, be retained, for the bid price of \$6,000.00. She further noted that the State Department of Economic Development will base their decision to go forward on the project on this study and information furnished by us in a pre-application. The study provided by The Hannon Company will also provide a cost benefit analysis. Mr. Argazzi asked if this is for the specific site? Mrs. Geary said yes. The Mayor said if we had more money we might include uses for the free land from Mr. Budney. He said he read that Newington is going to develop their land and sell it. Mr. Diskin reported that in 1975 the Town paid \$4,200 for a marketability study for the Berlin Industrial Mrs. Geary reported that the State feels that Hannon Company would do the job and that they would accept the recommendation from him. The study will take 45 days to complete. Mrs. Geary added that we will have to make available to them all information we have on sewer, water, labor market, etc. They will interview some of the major employees in Berlin. Mayor Ward said they will also give us a recommendation as to highest and best use of the land and whether the investment is worthwhile. Mrs. Geary said there is sewer on the site; the 18" interceptor. We would have to go out Deming Road for water. Mr. Argazzi asked if we would condemn this property? The Mayor said if it cannot be negotiated. On motion by Mr. Argazzi, seconded by Mr. McKeon, it was voted to approve the bid price of \$6,000.00 from The Hannon Company for a marketability study and cost benefit analysis for the Turnpike Industrial Park. MOTION CARRIED.

The Mayor presented a request from Mrs. Geary requesting an amendment to a resolution passed at a Town Meeting on January 17, 1983 concerning authorization to file an application to the State Department of Human Resources. She requests the amount be increased from \$400,000 to \$605,500. This reflects the cost estimate prepared by Quinn & Associates for the proposed Senior Center. On Motion by Mr. Argazzi, seconded by Mr. McKeon, it was voted to add this proposed amendment to the call of the Town Meeting scheduled for March 21, 1983. MOTION CARRIED.

The Mayor presented a request from Mrs. Geary for the Executive Board to sign a letter of intent that the Town of Berlin will use that portion of the Percival School defined in Paragraph 2 and referred in Paragraph 7 of the Agreement between the Town of Berlin and the Berlin Housing Authority dated January 3, 1983, as a Senior Center for a period of not less than twenty-five (25) years upon construction of improvements from the State before consideration can be given for funding the project. On motion by Mr. Argazzi, seconded by Mr. McKeon, it was voted to sign

the letter of intent of the Executive Board of the Town of Berlin to use that portion of the Percival School defined in Paragraph 2 and referred in Paragraph 7 of the Agreement between the Town of Berlin and the Berlin Housing Authority dated January 3, 1983, as a Senior Center for a period of not less than twenty-five(25) years upon construction of improvements required to satisfy that use. MOFION CARRIED.

Mr. Argazzi expressed to Mrs. Geary and Mr. Diskin his objection to a tax freeze for Chase Enterprises in the Webster Square area. He says he has desir t what he was supposed to do in the first place and now we will lose any increase in taxes. Mr. Diskin explained now we are getting taxes based on the stores occupied. The more the property runs down the less we are getting. Mr. Argazzi said he doesn't think legally it can be done. Following a brief discussion, Mrs. Geary and Mr. Diskin left the meeting.

Mayor Ward presented a Budget Change Form from Mrs. Joanne G. Ward, Town Clerk, in the amount of \$557.00 to account #1103 Senior Recording Clerk, Assistant Town Clerk. Mayor Ward explained this is to allow for the use of manpower services because of employee's illness in the Town Clerk's office. On motion by Mr. Argazzi, seconded by Mr. McKeon, it was voted to approve the Budget Change Form from Mrs. Ward in the amount of \$557.00 to account #1103 Senior Recording Clerk, with the understanding that this is to June 30, 1983. MOTION CARRIED.

Mayor Ward presented an Agreement to be signed by the Executive Board and George S. Einstein that on or before April 29, 1983 the buyer will pay to the seller the sum of \$45,000 conditioned upon fulfillment of the following conditions: approval of the Board of Education, and, approval of the Planning Commission; and approval by Town Meeting. Mr. Argazzi asked that we make it clear that the Town will not make a tax adjustment. On motion by Mr. McKeon, seconded by Mr. Ward, and voted to sign the Agreement concerning the Einstein property. OPPOSED: Mr Argazzi MOTION CARRIED.

#### CEMETERIES

The Mayor reported Mr. John Aguzzi wishes to retire effective immediately. He is seventy years old. He is willing to sell his equipment. It was agreed to retype the Contract Mr. Aguzzi had and advertise for a replacement.

DEMOLITION OF BARN

Mayor Ward advised the Board that the Finance Board has approved

the appropriation of \$2,770.00 to demolish the barn located on Town property on Kensington Road. It was agreed to notify the low bidder, Violette Used Brick Company, and advise him to obtain his required insurance and demolition permit.

Mayor Ward presented a letter from Morgan Seelye, dated February 28, 1983, advising that on April 15, 1981 Louis & Louise Valentine filed an easement with the Town Clerk for a sanitary sewer installed in their property on Spruce Brook Road. The description of the boundaries of the easement were in error and Atty. Jackaway feels the correcting documents should be filed in the land records, including a release by the Town for the area erroneously described. On motion by Mr. Argazzi, seconded by Mr. McKeon, it was voted to add this item to the call of the Town Meeting scheduled for March 21, 1983. MOTION CARRIED.

#### AGREEMENT

AGREEMENT this 31st day of January 1983, between the TOWN OF BERLIN, hereinafter referred to as "the Town", acting herein by its Executive Board, duly authorized, and the BERLIN HOUSING AUTHORITY for the Town of Berlin, hereinafter referred to as "H.A.", for the purpose of establishing the following guidelines:

- 1. The Town will convey to the H.A. the parcel of land with the building and improvements thereon situated southerly of Percival Avenue and easterly of Sbona Road containing approximately 5,77 acres known as the James Gates Percival School. This parcel is known and shown on a map entitled "A Property Map of Land To Be Conveyed to the Housing Authority of the Town of Berlin Colonial Drive, Berlin, Connecticut Date 1-12-83 | 1"=40" Bruce P. Soroka Associates No. Somer Drive, South Meriden, Connecticut" which map is to be filed in the Berlin Town Clerk's Office and is attached hereto, containing 251,538 square feet.
- 2. In consideration of the above, the H.A. will lease to the Town for \$1.00 and other valuable considerations, approximately 7,000 square feet of the James Gates Percival School for the use as a senior citizens' center the upper level of the southerly wing, which includes the all-purpose room. kitchen, toilets and various small offices as shown on the copy attached hereto. The Town will be responsible for the care and maintenance of the center as well as any repairs necessary during the lifetime of the lease.
- 3. Upon completion of architectual drawings, the Town will complete the renovation of this portion of the building in cooperation with and requirements of

the Berlin Commission for the Aging. Included in this renovation will be provisions for separate metering of all utilities used by the Senior Citizen Center, including electricity, heat, gas, and water for which the Town will be liable. The Town will also extend and improve the parking area at the southerly portion of H.A. premises, sufficiently to accommodate the needs of the senior citizens in the event of full utilization of the all-purpose room.

- 4. The H.A. will make provisions for tenant parking (20 parking spaces) and will be responsible for the care and maintenance of their portion of the building and grounds, i.e. lawn mowing and snow removal.
- 5. The Town also agrees to plow the main driveway and circle and also agrees to clear and maintain the senior citizen parking area. In addition, the Town will be responsible for clearing any sidewalks used by the senior citizens for ingress and egress to the Center.
- 6. The Town will carry liability insurance in the amount of \$300,000, and hold the H.A. harmless for any claim from any person or persons as a result of any accident while participating in any activities conducted by the senior citizens
- 7. If at any time in the future the Town does not desire to use this portion of the building for senior citizen activities, it will revert to the H.A.
- 8. The H.A. will grant the Town a fifty foot right of ingress and egress to other land owned by the Town presently used for recreational purposes, location of right-of-way will be determined at a later date.

Discussion about Applications for Recreational Trails Grants for Pistol

Creek/Lamentation Mountain and Hungerford Park

#### **Summary of Agenda Item:**

The State of Connecticut issued a request for applications for the Recreational Trails grant program. Applications are due March 1. The grant requires a 20% local match that can be provided by a cash match, in-kind services, or a combination of cash and in-kind services. Staff has initiated discussions about the grant program with the Town of Middletown about Pistol Creek, Lamentation Mountain trail improvements and with Hungerford Nature Center.

With the recent Berlin acquisition of a portion of the former Pistol Creek golf course, the Towns of Middletown and Berlin now own the entirety of the former golf course. Pistol Creek is also close to Lamentation Mountain via the Metacomet/New England National Scenic trail (NET) and the City of Middletown owns a large parcel south of the former golf course that could provide an additional connection to Lamentation Mountain. The Berlin Land Trust also recently acquired a parcel on Lamentation Mountain just south of the Berlin/Middletown town line that enhances the hiking experience on Lamentation Mountain. The concept for the Pistol Creek/Lamentation Mountain area grant application would be to submit the application as a two-town effort with project elements that may include improving Pistol Creek Cart paths on both the Berlin and Middletown sections, signage, constructing bog bridges on the section of the trail that enters Lamentation Mountain area from Spruce Brook Road via the Stantack Road right of way, and creation of a new trail link to Middletown's Atkins Road parcel including the construction of bog bridges, bridges and a small parking area.

The second potential grant application is for trail improvements at Hungerford Nature Center. The Hungerford Nature Center New Britain Youth Museum is a non-profit organization that operates programs for young people including at the Hungerford Nature Center site located on Farmington Avenue in Berlin. The Nature Center property is owned by the City of New Britain. A part of Hungerford's facility is a system of trails that are open to the public. The trails are used as part of Hungerford's youth outdoor education program. The trails at Hungerford are a valuable local resource, particularly for families with young children and for residents in nearby neighborhoods. The existing trails would benefit from improvements. The concept for the Hungerford Nature Center area grant application would be to submit the application as a two-town effort in concert with Hungerford Nature Center New Britain Youth Museum. Project elements may include bog bridges, small bridges, stone or woodchip installed on trails to improve the walking surfaces,

clearing of downed trees and brush, creation of a tree identification trail, signage and GPS mapping of the trails to include the trail system on Berlin's website.

Staff will return to the Town Council at a future meeting with more details on the Recreational Trails Grant applications including the amount and proposed source of matching funds.



one Fire Apparatus from Pierce Manufacturing.

#### **SUMMARY:**

James Simons, Fire Administrator, is requesting to waive the Town of Berlin bid requirements for the purchase of one (1) "Triple combination Fire Engine" from Pierce Manufacturing of Appleton, Wisconsin. This replacement is part of the long-term strategic plan for the Fire Apparatus replacement.

The Apparatus Replacement Plan (Plan) replaces the apparatus on a predetermined time frame providing safety, efficiencies in deployment and upgrades in technology. This plan was written in 2001 and accepted by the Town Council. It was subsequently reviewed, updated and presented to the Council in 2016. It was again reviewed in March of 2020 by the Board of Fire Chiefs for applicability and was re-adopted as it was presented in 2016. This piece of apparatus is the last of the four (4) purchased in 2002 and should be the last one purchased until 2028.

Pierce Manufacturing was selected by the Town's Board of Fire Chiefs originally in 2010 to build Engine 10. Following that build and the issues we had with other manufacturers and service centers, we recommended utilizing Pierce Manufacturing for the purchase of an additional seven (7) trucks (Tower Ladder 3, Truck 9, Squad 4, Engine 2, Engine 8, Engine 10 and Engine Tanker 12). The Board of Fire Chiefs is again recommending Pierce Manufacturing as the only choice in the replacement of this truck for the following reasons: a favorable past experience, workmanship, standardization of equipment, and the proximity of their factory service center.

James Simons, Fleet Manager and Fire Administrator, along with the Town of Berlin Board of Fire Chiefs, recommends that Pierce Manufacturing of Appleton, WI be awarded this purchase.

Originally Jim Simons, Fleet Manager estimated the cost to be approximately \$900,000, Working with the vendor the actual cost came in at \$948,360. This additional cost is a direct result of inflation and supply chain issues.

Funding has and will come from a few different sources:

• Surplus funding was transferred into the "Fire Truck" account #134.15.1531.0.54000.00018 for the deposit portion

- Cost overrun will be funded out of the "Vehicle Reserve" account# 134.15.1531.0.54000.00012.
- · Remaining funding was appropriated in outside bond resolution, unless surplus funding becomes available before delivery.

Delivery is estimated at 36 to 40 months from contract signing.

#### ACTION NEEDED:

Move to waive the Town of Berlin bidding requirements and award the purchase of one (1) Triple Combination fire engine (Engine 7) from Pierce Manufacturing, for an amount not to exceed \$950,000, as this is in the best interest of the town.



In 2007 (- the Present), Peter became Co-President of the Connecticut State Veterans Memorial in Hartford. Connecticut's first statewide Memorial that pays tribute to State heroes and heroines of the past, honors the veterans of today, and demonstrates the appreciation we hold for their service for generations to come.

In 2007, after Charlie Company, 1st Battalion, 25th Marines in Plainville, CT, returned from Fallujah, Iraq, the Marines of Charlie Company named him the "2006 Marine Corps Veteran of the Year". He received this honor for establishing a website for Marines in Iraq to see and communicate with their families in Connecticut. Peter was also the co-organizer for Charlie Company's Homecoming from Iraq and he created a DVD of all the pictures for the 200 Marines returning.

In 2008, Peter was the Public Relations Chairman for bringing the largest traveling Vietnam Wall to Rentschler Field in East Hartford. He was also instrumental in bringing up the Marine Corps Silent Drill Team and the Drum and Bugle Corp.

On 17 November 2010, Peter at Middlesex Community College dedicated its new Veterans' OASIS Center, a place where Veteran Students can congregate, relax, talk, study, and seek assistance from Peter, the Veterans Outreach Coordinator.

In 2011, Peter became a Board Member on the CT Trees of Honor. He helped Design the Living Trees Tribute and Created the Fallen Heroes Video for all the CT fallen service members who gave the ultimate sacrifice while deployed to Iraq and Afghanistan, post 911.

On 03 May 2011, Peter was appointed to be on the Town of Berlin Veterans Commission. On 07 February 2012, Peter was nominated to be the new Secretary of the BVC.

On November 8, 2011, Peter Galgano Jr. received the "William J. Pomfret Veteran Community Service Award". The award was presented by the Middlesex County Chamber of Commerce "Honor the Veterans and Support the Troops Committee" in recognition of distinguished service on the part of a veteran of our armed forces to the citizens of Connecticut and selfless devotion to the ideal of commitment to public service.

On November 28, 2012, Peter Galgano Jr. was inducted into the "Connecticut Veterans Hall of Fame". The Connecticut Veterans Hall of Fame honors veterans both for their direct service to their country and for making significant contributions to their local communities after they have completed their military service.

In 2013, Peter had the idea of creating the America's Wars Walkway at the Berlin Veterans Memorial Park. It took about two years to design the signs and get approval from the Department of Defense for the pictures and statistics used on the fiberglass embedment signs. In 2015, the signs were installed in the Berlin Veterans Memorial Park. We now have school busses from across the state who come to the park with students to learn about the history of America's Wars.

On April 29, 2015, Berlin Veterans Commission member Peter Galgano was named "Berlin's volunteer of the year" at the annual economic development awards at The Baltic Restaurant in Berlin, CT. "Peter has an extensive record of volunteering to recognize and assist veterans of military service," said Town Manager Denise McNair. When Galgano returned from Vietnam, he "hung up" his uniform for years. Later, he started to dedicate much of his time to making things better for other returning vets. "I don't want them to lose the time I did," he said. Galgano "has once again gone above and beyond the call of duty" in the work he put into planning the recently-dedicated Veterans Memorial Park near Stop & Shop and The American Legion, McNair said. Galgano, who also created and designed the America's Wars Walkway signs, "saved the town thousands of dollars in sign design fees" and "added a personal touch to the project that we will all appreciate," she added.

On September 16, 2015, At Middlesex Community College, Peter Galgano had the dedication ceremony for the MxCC Veterans Memorial Garden. Peter and 12 student veterans dug out and built a Veterans Memorial Garden, a space to honor and remember all veterans. The location of the garden is one of high prominence situated along the main entrance walkway leading to Chapman Hall. This is the most visible location on campus to the students, staff, and community visitors. The design includes a memorial patio seating area, another area with an engraved monument, and military steppingstones for each branch of service, and plants that make the area peaceful, attractive, welcoming, and sustainable.

On November 9, 2015, the CT State Veterans Memorial was dedicated. The landmark event was coordinated by the dedicated committee of veterans and volunteers of the Connecticut State Veterans Memorial, Inc., a nonprofit organization established exclusively to raise funds for and build a statewide memorial to honor all Connecticut veterans. Sergeant Peter Galgano Jr. serves as Co-President of the Connecticut State Veterans Memorial Board of Directors. The park is located inside of Minuteman Park at the intersection of Capitol Avenue and Broad Street in Hartford – directly in front of the William A. O'Neill State Armory – the memorial pays

tribute to the more than 1.3 million men and women from Connecticut who served honorably in the U.S. military in defense of our freedom. It recognizes past, present, and future Connecticut veterans and will serve as a site for official observances, activities, and ceremonies that honor veterans.

On November 11, 2015, on Veterans Day, the Berlin Veterans Commission dedicated the new "America's Wars Walkway", a path around the park with 13, 36" x 24" fiberglass embedment signs with the history of America's Wars from the American Revolution through the Afghanistan and Iraq Wars. Peter Galgano Jr. came up with the idea over two years ago, while in Fort Huachuca, AZ. He saw the signs for the Buffalo Soldiers and came up with the idea of the America's Wars Walkway. He thought what a wonderful way to give a history lesson about how we have the freedoms we have today and at the same time, learn about the sacrifices all of our veterans have made for our country. It took about two years to research the history, get the pictures, create the design & concept, get approval from the DOD, and with the Berlin Veterans Commission and the Economic Development Committee, make it a reality.

On March 1, 2016, Peter Galgano Jr. has officially been appointed as the Town of Berlin "Municipal Veterans Representative". He serves as the main coordinator in serving veterans and their families. He will be in charge of assisting veterans as they adjust to life outside the service and help in their transitions. Galgano's role also includes setting up the activities involved with public and private facilities that are in charge of reemployment, education and rehabilitation of veterans. Among many other responsibilities, He will be the primary person that veterans can seek for help.

On March 18, 2016, Peter Galgano was appointed to the Board of Trustees for the Connecticut Department of Veterans Affairs. The board shall be comprised of eighteen voting members who by education and/or experience shall be qualified in health care, business management, social services, or law and who shall have a demonstrated interest in the concerns of veterans. The board shall advise and assist the commissioner in the operation of the Veterans

Residential Services facility, the Office of Advocacy and Assistance, the administration, expansion or modification of existing programs and services of the department and the development of new programs and services.

In January 2018, Peter Galgano was contacted by the VFW's Women's Auxiliary to update the pictures that were on the wall in the Berlin Town Hall's Rotunda. There were 10 – 15 pictures of Berlin Veterans who were serving in the military but hasn't been updated in two years. Peter said yes but had a better idea and brought it up at the next Berlin Veterans Commission meeting. He proposed to make a video presentation of pictures and information of all Berlin Veterans who are serving or have ever served in the military. So, after months of getting pictures and information from Berlin residents, he created the Video Berlin Veterans Wall of Honor.

In November 2018 (- the present), the Video Wall of Honor was dedicated in the Rotunda in Berlin's Town Hall. We now have 346 veterans on the Berlin Wall of Honor and, a Digital Version on YouTube that Galgano created.

On March 22, 2019, Peter Galgano Jr. was appointed to the Board of Directors for the Friends of VA Connecticut Fisher House Inc. Fisher House provides high quality, temporary lodging, at no charge, to families/caregivers of Veterans and Active-Duty Service Members who are undergoing inpatient or extensive outpatient treatment provided by the VA or Department of Defense (DOD). Fisher House is a "home away from home" and offers a warm, compassionate environment and a sense of comfort while a loved one is undergoing medical treatment.

In November 2021, Peter was appointed to the Woody Williams Foundation CT Gold Star Families Memorial Monument Committee and in January 2022, he was able to get Gold Star Mother Helen Keiser-Pedersen and Veterans Commission Chairman Charles Colaresi appointed to the WWF CT Gold Star Families Monument Committee.

This Monument was **dedicated on April 23, 2022,** in the **Berlin Veterans Memorial Park**. Gold Star Family members and relatives are those who have sacrificed a Loved One for our Freedom.

Peter is presently active with the following: The Marine Corps League #781, in New Britain, and the MCL Dept of Connecticut, the VFW Post 10732 and the American Legion Post 68 in Berlin, CT, the Vietnam Veterans of America, Chapter 120 (Board of Directors), in East Hartford and the VVA State Council-Vice President, the town of Berlin Veterans Commission, the town of Berlin Municipal Veterans Representative, Co- President of the CT State Veterans Memorial Inc., member of the Special Veterans Advisory Committee for Senator Richard Blumenthal, the Veterans' Outreach Coordinator at Middlesex Community College, the Staff Advisor for the Middlesex Community College Veterans Club, an Outreach Coordinator for the OEF/OIF Military Support Committee, at Maj. Gen. Maurice Rose Armed Forces Reserve Center in Middletown, and the Connecticut Department of Veterans Affairs Board of Trustees.

## Visiting Nurses Association (VNA)

Town Manager Jayawickrema stated that the VNA is currently presenting its report to the Board of Finance and will present to the Town Council after New Business items.

### I. <u>NEW BUSINESS</u>:

1. Topic re: The Town of Berlin authorizes the solicitation of bids for a consultant, for the purposes of completing, submitting and administering a grant application for the Community Development Block Grant Program. If the Grant is approved, the Berlin Housing Authority will be the sub-recipient of those grant monies, subject to review and approval of Corporation Counsel. – Housing Authority

Housing Authority Chair Joe Bajorski stated that the Housing Authority is looking to obtain a Community Development Block Grant (CDBG) for improvements and repairs needed at the Percival Heights and Marjorie Moore Village senior housing complexes. Repairs include, but are not limited to, the replacement of roofs and rain gutters, sky light replacement, and installation of new floor coverings at both complexes.

The Housing Authority will work in coordination with the Town of Berlin to solicit bids from consultants for the technical and administrative services required for the preparation, submission, and administration of the grant application.

Councilor Paonessa moved to authorize the Town of Berlin to solicit bids for a consultant, for the purposes of completing, submitting, and administering a grant application for the Community Development Block Grant Program. If the Grant is approved, the Berlin Housing Authority will be the sub-recipient of those grant monies, subject to review and approval of Corporation Counsel.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

2. Topic re: Authorize the Town Attorney to enter into discussions with Pullman Comley, attorney representing the Berlin Housing Authority, to prepare documents to facilitate transfer of title and ground lease execution for parcels of land at 143 Percival Avenue, known as the Knights of Columbus property, along with land left over from the construction of the Percival Park Soccer Fields and to authorize the Town Manager to extend the Option Agreement between the Town of Berlin and the Berlin Housing Authority until March 30, 2023, to facilitate the transfer of title process. – Housing Authority

Town Manager Jayawickrema stated that Housing Authority Chair Bajorski would provide an overview of the Senior Housing project and the funding arrangements associated with the project.

Chair Bajorski stated that for the past seven years the Housing Authority has been working to put the Senior Housing project together and they are at the point now where they have secured the \$33 million needed to move forward.

As part of the process to close on the construction funding the Housing Authority is requesting that the Town of Berlin enter discussions with their attorney for the preparation of documents for the transfer of title and ground lease execution for the two parcels of land, currently under control of the Town of Berlin, that comprise the "Knights of Columbus" parcel at 143 Percival Avenue and land left over from the construction of the Percival Park Soccer Fields which will require a ground lease.

Mr. Bajorski introduced Rob Cappelletti of Northeast Redevelopment Services LLC (Northeast); the developer hired to oversee the construction. Mr. Cappelletti is also responsible for securing funding for the project. Mr. Bajorski also introduced Maria DeMarco, the principal of DeMarco Management Co. the management agency for the Berlin Housing Authority. Ms. DeMarco assists with the selection of tenants.

Town Manager Jayawickrema asked Mr. Bajorski to provide a synopsis of how the funding is structured and Mr. Bajorski asked Mr. Cappelletti to speak on that.

Mr. Cappelletti explained that Northeast Redevelopment Services LLC is the for-profit arm of Greater Groton Realty Corporation with is the not-for-profit arm of the Housing Authority. Their lender has issued the funds for the project provided that the property transfer can be made to the Housing Authority and all necessary paperwork needed can be obtained from both attorneys.

Town Manager Jayawickrema inquired if there was a commitment letter stating conditions to be satisfied for closing. Mr. Cappelletti stated that Northeast would issue that to Berlin Affordable Inc,

and it will be a term sheet based on what the lenders say how the funds are passed through for construction completion. After that point bonds are issued or the bonds interest rate is higher, they stay with the lenders \$33 million loan which can be refinanced after 15 years.

Town Manager Jayawickrema asked if there was a document that could be provided to Corporation Counsel stating that the funds are available in escrow specifically for Berlin's project. Mr. Cappelletti stated that there was a letter provided that states the pool of available funds and included a list of projects which includes Berlin. The Town Manager stated that letter was not received by the Town.

Mr. Cappelletti stated the next step would be a specific term sheet to Berlin Affordable Inc under the Berlin Housing Authority with the general conditions of the funds. Town Manager Jayawickrema stated that it would be helpful to have that term sheet in order to recommend to the Council to move forward with the title transfer. It would also state what is in place for collateral and mortgage promises, and default provisions. Also, if the Town is liable for anything.

Mr. Cappelletti explained that these are non-recourse loans, the building improvements become the collateral once it is done, and Wells Fargo Statutory Trust looks at the types of projects that Northeast does which give back to the community which is why they are lending to this project.

Mr. Bajorski stated that in addition to the items mentioned by Mr. Cappelletti, the Berlin Housing Authority is issuing a private placement bond sale which will collateralize the \$33 million construction cost.

There was discussion that tonight's motion is simply to extend the Option Agreement and to allow attorneys from both sides to begin discussions.

Councilor Paonessa inquired if the project was approved to be age-restricted housing. Mr. Bajorski stated that because of the site-plan approval the site is restricted to a certain age group, and as a result that gets the project around the State of Connecticut Department of Housing hurdle.

Councilor Fazzino asked for clarification on the various entities involved. Mr. Bajorski explained that because of the 4% low-income tax housing credit program the Berlin Housing Authority can not own the property. In order to facilitate ownership, the Housing Authority created a 501-c3 nonprofit called Berlin Affordable Housing, Inc which is solely owned by the Housing Authority. This allows the Housing Authority to develop housing which qualifies for low-income tax credit financing.

Mr. Bajorski continued by explaining that Northeast was hired by the Berlin Housing Authority for the purpose of developing the Knights of Columbus Project.

The Town Council discussed making two motions on this agenda item and reversing their order to extend the Option Agreement date first.

Councilor Paonessa moved to authorize the Town Manager to extend the Option Agreement between the Town of Berlin and the Berlin Housing Authority until January 31, 2023, to facilitate the transfer of title process.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

Councilor Paonessa moved to Authorize the Town Attorney to enter into discussions with Pullman Comley, attorney representing the Berlin Housing Authority, to prepare documents to facilitate transfer of title and ground lease execution for parcels of land at 143 Percival Avenue, known as the Knights of Columbus property, along with land left over from the construction of the Percival Park Soccer Fields.

Seconded by Councilor Veach.

5. Topic re: Update to Town Council regarding Demore, Dinda, Bittner Jr. Memorial Pool. – Parks and Recreation Commission

Parks and Recreation Commission Chair Donna Bovee stated that the Parks and Recreation Commission has been discussing the condition and the operation of the Demore, Dinda, Bittner Jr Memorial Pool (DDB) in East Berlin with Town staff over the course of the last several months.

The current situation is the main pool and deck require major repairs due to surface cracks, the stairs in the pool are warped, and the pool loses about five inches of water a day from under the cutters. The pool remains safe to swim in and patching is done every year. What has been identified as a fix is inserting a liner over the gunite surface.

The wading pool at the complex has not been opened since 2019 due to repairs needed. There has not been much of a push-back from residents regarding opening the wading pool.

Due to staffing issues this past year, the pool was only open Monday – Friday, while Percival Pool is open seven days a week. Usage of the pool has decreased to 931 visitors in 2022 from over 3,000 in 2017.

Ms. Bovee stated that if the Town decided to open only one pool complex the current users of the East Berlin complex could be absorbed into the Percival complex as the attendance there has also declined slightly.

The current plan for 2023 is to open Percival seven days a week, DDB five days (Monday – Friday), and no wading pool which is the same plan as 2022. This assumes there is staff available to man both pools and they should have a better idea of staffing by early February.

There is a \$250,000 in the budget for a pool liner, but the Parks and Recreation Commission wanted to do better identify repair work required and understand options before spending the funds. The Commission requests that the funds be carried over and used once there is a recommendation.

Ms. Bovee stated that some towns are doing away with pools and replacing them with splash pads that require no supervision by staff, but they can be expensive to install. There is also a cost associated with closing a pool which could be about \$300,000. Ms. Bovee added that the DDB pool complex is also not ADA compliant.

Councilor Fazzino inquired about maintenance costs for a splash pad. Director of Community, Recreation, and Park Services Jen Ochoa stated that water costs are minimal since water is recycled through the system and the area would require less supervision than a pool, saving those costs too. The cost to install a splash pad could be in the half a million-dollar range. Councilor Fazzino suggested having an informational meeting at Hubbard School for area residents.

6. Topic re: Approve and authorize the Town Manager to enter into a contract with the Berlin Middle Management Association from July 1, 2022 through June 30, 2025. — Human Resources

Human Resources Director Paula Carabetta stated that notable changes to the Middle Management Association contract include language cleanups, making sure that it falls in line with other current union contracts, and updated safety equipment allowance reimbursement amounts. Salary increases are 2.25% for FY2022, 2.5% for FY2023, and 2.75% for FY2024. Ms. Carabetta added that those increases are in line with other towns, and in some cases below other towns' increases.

Town Manager Jayawickrema added that the Town is working with a new Labor Attorney from Halloran and Sage, and he has been very helpful.

Councilor Paonessa moved to approve and authorize the Town Manager to enter into a contract with the Berlin Middle Management Association from July 1, 2022 through June 30, 2025.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

7. Topic re: Approve and authorize the Town Manager to enter into an Extension of Employment Agreement with Chief of Police, Matthew McNally, from November 1, 2022 – October 31, 2026. – Human Resources

Town Manager Jayawickrema introduced this item stating that this extension to the Police Chief's Employment Agreement was unanimously voted on by the Police Commission at their November 16, 2022 meeting.

Human Resources Director Carabetta added that this four-year agreement is considered an extension of the original Employment Agreement with no changes other than to the salary.

Councilor Paonessa moved to approve and authorize the Town Manager to enter into an Extension of Employment Agreement with Chief of Police, Matthew McNally, from November 1, 2022 – October 31, 2026.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

# 8. Topic re: Authorize the Town Manager to Request Proposals to study the three Water/Sewer Districts in the Town of Berlin. – Water Control

Water Control Manager Ray Jarema stated that the Berlin Water Control Commission (BWCC) met on November 22, 2022 and discussed the issue about the potential evaluation of the three water districts in Berlin to assess their Technical, Managerial and Financial Conditions to serve the needs of water and sewer for Berlin.

A 1996 and 1998 a study was conducted by Fuss & O'Neill without a definitive conclusion. The BWCC feels it is time to have a detailed analysis of Berlin Water Control, Kensington Fire District, and Worthington Fire District. Mr. Jarema added that the previous Fuss & O'Neill study concentrated only on water rates and not sewer rates.

The Commission believes it is necessary that the Town has an independent consultant evaluate each district to determine strengths and weaknesses. There is concern that if there is ever a default like the East Berlin Fire District in 1966, the Town must recognize there will be an obligation that it would inherit.

Mr. Jarema added that both Worthington and Kensington Fire Districts have stated that they do not want to contribute to the study.

BWCC member Liam Mitchell stated that he recently was also appointed to the Mattabassett Water District, and they are also very much concerned as they are close to maxing out their capacity.

Mr. Jarema added that it was just discovered that the Baxter Avenue meter was not recording properly, and the calibration was off.

Councilor Paonessa moved to authorize the Town Manager to Request Proposals to study the three Water/Sewer Districts in the Town of Berlin.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

9. Topic re: Utilize various State, National and Consortium purchasing contracts and approve purchase orders up to \$25,000 as needed in Departments 38 Public Buildings and 61 School Expenses, contractual services accounts without exceeding the account balances during fiscal

year 2023 for the following vendors: Matson Rugs, John Boyle, McBride Carpets, M. Frank Higgins, Dalene Flooring, Greenwood Industries, Northeast Interior Systems, KMK Insulation, Disaster Restoration Services, and Encore Holding. – Facilities

Director of Facilities Doug Solek stated that this item is for maintenance items and projects in the pipeline where the \$10,000 purchasing guideline threshold will be exceeded. Projects will include school and Town buildings, as well as Timberlin Golf Course.

Councilor Paonessa moved to utilize various State, National and Consortium purchasing contracts and approve purchase orders up to \$25,000 as needed in Departments 38 Public Buildings and 61 School Expenses, contractual services accounts without exceeding the account balances during fiscal year 2023 for the following vendors: Matson Rugs, John Boyle, McBride Carpets, M. Frank Higgins, Dalene Flooring, Greenwood Industries, Northeast Interior Systems, KMK Insulation, Disaster Restoration Services, and Encore Holding.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

10. Topic re: Utilize Omnia Partners National Agreement EV2370 and approve the purchase of Chromolox heat trace cable to replace the cable within the gutters and downspouts and associated accessories at Town Hall from Graybar Electric of Wallingford, CT for an amount not to exceed \$36,258 which includes a 10 percent project contingency. – Facilities

Director of Facilities Solek explained that the heat trace wire within the gutters and downspouts at Town Hall is no longer operable. The new enhanced cable offers a ten-year warranty along with improved durability and performance.

Funding was allocated in FY2022 for this project and will be done in conjunction with gutter and masonry work along the perimeter of the Town Hall building and will provide ice and snow melt to assist with gutter drainage.

Councilor Paonessa moved to utilize Omnia Partners National Agreement EV2370 and approve the purchase of Chromolox heat trace cable to replace the cable within the gutters and downspouts and associated accessories at Town Hall from Graybar Electric of Wallingford, CT for an amount not to exceed \$36,258 which includes a 10 percent project contingency.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

11. Topic re: Award Contract No. 2023-08 for Construction Management Services on the Emma Hart Willard Elementary School HVAC Project to Newfield Construction Group LLC of Hartford, CT in an amount not to exceed \$934,625. – Public Works

Public Works Director Mike Ahern stated that the Public Building Commission (PBC) issued a Request for Proposals for Construction Management Services for the Willard Elementary School

HVAC upgrade project. Two bids were received with Newfield Construction Group providing the lowest bid with an estimated project duration of 18-months.

As a result of the interviews, and review of the submitted qualifications, costs and work plans, the PBC recommends awarding the contract to Newfield Construction in the amount of \$934,625; this includes contingency in the event the construction period does go beyond 18 months up to 24 months.

Councilor Paonessa moved to award Contract No. 2023-08 for Construction Management Services on the Emma Hart Willard Elementary School HVAC Project to Newfield Construction Group LLC of Hartford, CT in an amount not to exceed \$934,625.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

12. Topic re: Authorize the Town Manager to accept the attached bid results for the Equipment Rental Contract (#2023-10) and utilize the services of: JV III Construction, Earth Contractors, Staxx Construction Services, Cariati Developers, Inc., and Valli Construction, Inc. when issuing future purchase orders to one or more Firms, depending on vendor availability and cost-effectiveness, through December 31, 2024. – Public Works

Public Works Director Ahern stated that the Public Works Department received bids for "Equipment Rental" from five contractors on December 2, 2022. Heavy equipment and labor from this bid would be utilized to assist the Highway Department and Public Works Staff (as well as other Town Departments), on an as-needed basis, on road reconstruction/public works projects, as well as the completion of subdivisions, where the bonds have been called by the Planning and Zoning Commission. Various pieces of construction equipment would be utilized from excavators and bulldozers to dump trucks and manual labor forces. Rates, as proposed, are valid through December 31, 2024.

Dependent upon the work proposed and the type of equipment required, contractors may be chosen based upon the hourly rate submitted for that piece of equipment. Funding to provide for payment will come from various sources dependent upon the specific site where the work will be performed. Due to the nature of the work, we are requesting that Council accept all five bids that were received. Staff will utilize the most efficient and responsive contractor available to perform the required work. Due to the uncertainty of our rental needs at this time, it would be inappropriate to assign a specific dollar value to this contract. Funding would be provided from the appropriate construction-related project accounts.

Councilor Paonessa moved to authorize the Town Manager to accept the attached bid results for the Equipment Rental Contract (#2023-10) and utilize the services of: JV III Construction, Earth Contractors, Staxx Construction Services, Cariati Developers, Inc., and Valli Construction, Inc. when issuing future purchase orders to one or more Firms, depending on vendor availability and cost-effectiveness, through December 31, 2024.

Seconded by Councilor Veach.

13. Topic re: Extend Contract #2021-03 (Scrap Metal Disposal), with Calamari Recycling Company, Inc. of Essex, CT through December 31, 2024. – Public Works

Public Works Director Ahern stated that the Town currently has a contract with Calamari Recycling Company, Inc (Calamari) for Scrap Metal Disposal through December 31, 2022. Calamari's bid price was 105% of the monthly market price for light iron/mixed materials generated from the Town's curbside collection and the Town's Transfer Station.

Calamari has offered to extend their existing rates for the next two years and both Public Works staff and Transfer Station staff are pleased with the service provided by Calamari.

Councilor Paonessa moved to extend Contract #2021-03 (Scrap Metal Disposal), with Calamari Recycling Company, Inc. of Essex, CT through December 31, 2024.

Seconded by Councilor Veach.

Councilor Paonessa moved to approve utilizing the State of Connecticut Department of Administrative Services Contract Number 22PSX0010 for Bituminous Concrete through April 30, 2024, or to a new expiration date as extended by the State.

Seconded by Councilor Veach.

15. Town Manager Jayawickrema stated that the Ordinance Committee met on December 8, 2022 and voted to recommend to the Town Council to increase the bid threshold for the purchase of goods and services to \$25,000. Currently Chapter 5-5 of the Town Charter states that Town Council approval is required for purchase or contract to purchase for \$10,000 or more.

This request is to hold a Public Hearing to receive public comments on the matter.

Councilor Paonessa moved to set a public hearing on January 3, 2022, at 6:45 PM at the Town Council Chamber for the purpose of receiving both written and oral comments concerning new text to Chapter 16 – Taxation and Finance – to increase the bid threshold for the purchase of goods and services to \$25,000 and the criteria for bid waivers.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

### VNA Report – previously Agenda Item H

Berlin VNA Administrator/Clinical Supervisor Alea Piatek provided the Town Council with an update on the status of the agency and what she has been doing since starting work with the VNA.

Ms. Piatek stated that she did her assessment on the agency and identified some issues in the structure of the day-to-day workflow and worked to correct that. She continues to work on the foundation of the agency and to make sure things are organized, processes are being followed in the correct manner by all and determining what the expectations are of the agency.

Some initiatives to decrease costs include education to staff so that they have more accurate assessments, as those initial startup care assessments drive part of the VNA's revenue and replacing some per diem physical therapy staff with a new per diem staff member who is aware of the new payment models and that has been working out well.

Medical supplies were evaluated for less expensive options and another visit nurse was added to decrease the overtime of the full-time staff. The relationship with the assisted living facility in West Hartford was discontinued as it was not bringing in the patients it was expected to bring and was very time consuming for staff. The JAHCO certification was also discontinued as it is no longer required resulting in a savings of a few thousand dollars a year.

The VNA has increased its community outreach to Town residents to make them aware that the VNA is ready and able to assist with homecare needs, as well as to give value to other areas of the community beyond homecare patients and school students by holding community events.

Out of town patients have been reduced from about 40% to between 14% and 20%. Total monthly patients have increased over 2021 with more admissions, less recertifications, and more discharges which means that the VNA is not only taking on more patients, but they are being more productive in the visits where patients do not need to be on service for as long.

In the upcoming fiscal year budget, the VNA was able to cut between \$15,000 and \$20,000 and they are looking to build revenue. Current census is 75 patients and that is manageable with the current staff, and she is looking to create relationships with at least three referral sources to increase the census. Ms. Piatek added that she is working with the Board of Finance and the Director of Finance to create one, three, and five year goals and plans to decrease losses.

Councilor Coppola inquired about the discontinuation of the JAHCO certification. Ms. Piatek explained that it is considered outdated and would not affect referral resources. The Councilor also inquired about the reduction in out-of-town patients. Ms. Piatek stated that the focus is on servicing Berlin patients and patients from towns that border Berlin.

Councilor Fazzino inquired about the decrease in out-of-town patients and questioned if that is where the VNA wants to be for the next year or two. Ms. Piatek stated that she believes the VNA should continue to have out-of-town patients but focus on Berlin and if the number of Berlin residents is reduced for a month it will allow the VNA to take on patients from surrounding communities.

Town Manager Jayawickrema stated that Ms. Piatek joined the Town with experience from Hartford Healthcare, VNA, and Board of Education and that has made a tremendous difference.

- The Town will be hosting a Meet and Greet for new employees on Wednesday December 21<sup>st</sup> at noon if any Town Council members would like to attend.

### L. <u>SPECIAL COMMITTEE REPORTS</u>:

The Ordinance Committee met to discuss the issue with ATV noise, and it is still being worked on. The Committee also voted to recommend to the Town Council to increase the bid threshold for the purchase of goods and services to \$25,000 as discussed in item #15 this evening. The next meeting of the Ordinance Committee will be held on January 5, 2023.

### M. COUNCILORS' COMMUNICATION:

Councilor Fazzino offered congratulations to the Berlin High School football team for a very successful season, finishing second in the State. Mayor Kaczynski stated he will be in touch with the team's coach to recognize them during a Council meeting.

Councilor Fazzino also stated that tomorrow, December 14, 2022, is the 10-year anniversary of the Sandy Hook school shooting. The Council took a moment to reflect on the students and teachers who lost their lives that day, as well to appreciate law enforcement and those that continue to make our community safer.

Councilor Veach stated that Wreaths Across America will be placing over 1,200 wreaths at Fairview Cemetery in New Britain on Saturday. All are welcome to assist in placing wreaths. A ceremony was also held this morning at the Gold Star Families Memorial in Berlin.
