SUBJECT:

Approval for Site Work at Berlin High School for the Full-Day Pre-K Program

#### **Summary of Agenda Item:**

The Berlin Public Schools is expanding the current Pre-K program to a tuition-based full-day program for the upcoming school year (September 2025). Currently, the program operates solely at Willard Elementary School (4) classrooms, (2) half-day sections/day.

The full-day program requires an additional Pre-K classroom and the district has determined that the child development classroom at Berlin High School will serve as the fifth classroom. This classroom requires minimal modifications within the building; however, it will require changes to the exterior to include a fenced-in outdoor recreation area.

In the fall of 2024 Earth Contractors issued an estimate to provide a safe and level area for the Pre-K program. The project includes removal of tree stumps, a block retaining wall, grading and removal of extra fill, and installation of proper drainage, play safe mulch, and fencing. The Board of Education staff will continue to work with the Town's Facility, Planning and Zoning, Public Works and Grounds Departments throughout the duration of this project.

The Board of Education received \$50,000 from the Community Foundation of Greater New Britain to fund the cost of the outdoor play area, and is seeking council approval to utilize the on-call vendor list to provide site modifications for the school sponsored program.






SUBJECT: Willard School Original Student Restroom Repairs

#### **Summary of Agenda Item:**

The original sanitary and domestic piping within the two student restrooms in the original section of Emma Hart Willard School has begun to deteriorate and leak. Temporary repairs have been done over the years to maintain service and operations but are now at a point where the concrete slab must be excavated, and substantial repairs and associated work must be performed to maintain operations. The project was developed during the fiscal year 2026 capital planning process with funding allocated through the Berlin High School Renovation Project Reimbursement Funds. Due to the timing needed to complete the repairs during the 2025 summer recess in the school and a limited budget, a design build repair approach and scope was developed between Town Staff and On -Call Contractors utilizing all existing conditions information available to address and repair all deficiencies in a phased approach. The scope and budget will not encompass full demolition and renovations of the 2 restrooms but will address the piping deficiencies and include some fixture and flooring replacements. This will allow for additional remodeling renovations to occur when additional funding becomes available. On-Call Contractor Aresco Construction of Middletown, CT has provided a prevailing wage estimate for an amount not to exceed \$71,000 which includes adding option 1 for their construction portion of the project. On -Call Contractor Central Mechanical Services of Cromwell, CT has provided a prevailing wage estimate for an amount not to exceed \$78,000 for their plumbing portion of the project. Both Contractors will work together with Town Staff to perform the work over the summer of 2025 during school recess.







Re: Berlin Willard School Bathroom Work Revised

Dear Mr. Solek:

The following is our budget cost for the bathroom work we reviewed on site this week. Our cost includes demo slab in janitor closet and bathrooms for new plumbing work, excavate and backfill, prep and pour concrete. We will open and patch block walls as needed to assist the plumber. We will remove and reinstall toilet partitions. We will patch floor tile in affected areas as necessary (men's room along entire urinal wall approx. 24" wide. New 4" ceramic tile will be installed 4 feet tall on toilet wall in both bathrooms. In the women's room we will install a new 4" wall floor to ceiling with 4" ceramic tile up to 4 feet tall and paint remaining wall to ceiling at the new sink area. We will remove and replace the entire tile floor with new 2x2 ceramic tile. Cost includes floor protection in hallway and air filter during demolition work.

Add Option 1 - Remove all floor tile men's bathroom and install new 2x2 tile.

Cost

\$9,000

Add Option 2 - Paint wall above glazed block and door frames in both bathrooms

Cost

\$4,800

All work will be done on a not to exceed basis per scope above. As discussed, there are some unknows such as concrete thickness, depth of existing piping for excavation, etc. Any savings will be passed back to the owner. All costs include prevailing wages.

SUBJECT: Sage Park Softball and Baseball Field Lighting Upgrades

#### **Summary of Agenda Item:**

The softball and baseball field lights at the Sage Park Complex are close to 30 years old and are due for an upgrade due to maintenance and performance factors. Several LED upgrade options were reviewed and submitted to the PBC for review and recommendations. At the PBC meeting on May 8, 2025, the decision and recommendation to proceed with the quote received from Musco Sports Lighting of Oskaloosa, IA in the amount of \$292,000 was approved, utilizing Sourcewell Contract No. 041123-MSL. A 10 percent project contingency is requested bringing the total project cost to an amount not to exceed \$321,200. The project will be submitted to Eversource for review with the intent of the Town being eligible to qualify for any potential incentives and rebates. Project funding was provided from the Berlin High School Renovation Reimbursement for Phase 1 of the Sage Park Field Lighting Upgrades which include the Softball and Baseball Fields. Once these fields are completed, any current project funding balance will remain in the project account to be utilized in the second phase, which will include the LED field lighting upgrades at the football field, which is the third and final field at the Sage Park Complex to be funded in future budgets.

### J. NEW BUSINESS:

### 1. Topic re: Discussion and possible action concerning the budget. - Town Clerk

Town Manager Ryan Curley stated that at the April 29<sup>th</sup> Budget Referendum the General Government budget did pass but the Board of Education (BOE) budget did not pass with voters stating that the budget was too high.

The Board of Finance met last night and made no changes to the budget and therefore it is now up to the Town Council to make any changes to the budget and send it to a referendum on May 27<sup>th</sup>.

Councilors Atkinson, Pruzin, and Veach expressed frustration with the voter turnout as well as voters not understanding the advisory question regarding whether the budget is too high or too low. Mayor Kaczynski and Councilor Veach stated that they understand that those have been ongoing concerns, however the Town has to listen to the voters that did turn out and, in this case, they want to see the BOE budget reduced. He added that the only way for changes to the process to be implemented is through Charter revision.

Councilor Rosso stated that he believes that the other 95.6% of voters that did not turn out to vote agree with the budget presented therefore he can not support lowering the BOE budget.

Councilor Veach stated that she suggests a very small decrease in the BOE budget to at least listen to what the voters requested.

Councilor Paonessa agreed that despite the low turnout the Council needs to respect the voters that came out and he suggested a \$50,000 decrease in the BOE budget.

Councilor Atkinson stated that 368 people voted no on the BOE budget, however 388 people answered that advisory question which means that 20 people answered that question that shouldn't have, and the Town does not have a true representation of what the voters' intentions were. She therefore cannot agree to reducing the education budget.

Councilor Coppola agreed with the \$50,000 decrease in the BOE budget stating that in previous years the Council listened to the voters and increased the budget when they stated that it was too low and should therefore listen to the voters this time too.

Finance Director Kevin Delaney stated that a \$50,000 reduction would bring the overall BOE budget from a 4% increase to a 3.9% increase and bring the mil rate to 30.66 or a 0.45 mil increase.

In regard to Charter Revision, Town Clerk Kate Wall reminded the Town Council that the Charter Revision process will take some time due to the number of public hearings and meetings needed. Placing the question on the November 2026 ballot is a good target as there is traditionally higher voter turnout for the gubernatorial election.

Councilor Paonessa moved to reduce the Board of Education budget by \$50,000 based upon the April 29, 2025 Budget Referendum results.

Seconded by Councilor Veach.

Those voting in favor: Councilor Coppola, Councilor Paonessa, Councilor Veach, Mayor Kaczynski.

Those voting against: Councilor Atkinson, Councilor Pruzin, Councilor Rosso.

Vote being 4-3 (MOTION CARRIED)

2. Topic re: Approve the Willard School replacement boiler, burner and accessories quote from Torrco Supply of Bristol, CT utilizing MHEC Contract pricing for an amount not to exceed \$55,000 which includes a 10 percent contingency also approve the Willard School Boiler replacement labor quote from On-Call and State Contractor Central Mechanical Services of Cromwell, CT for an amount not to exceed \$21,400 which includes a 10 percent contingency. – Facilities

Town Manager Curley introduced this item stating that the two boilers at Willard School are in need of replacement and this request is to replace one of the boilers at this time with funding that is currently in place. This would be a one-for-one replacement purchased via State contract with install labor from the Town's current on-call contractor.

Director of Facilities Doug Solek stated that this first boiler replacement project is being moved up due to issues it has been having over the past couple of winters. An engineering assessment was performed with replacement options reviewed and approved by the Public Building Commission. The second boiler will be requested in a future budget.

Councilor Paonessa moved to approve the Willard School replacement boiler, burner and accessories quote from Torrco Supply of Bristol, CT utilizing MHEC Contract pricing for an amount not to exceed \$55,000 which includes a 10 percent contingency.

Seconded by Councilor Veach.

Town Manager Curley stated that as a condition of receiving financing for Newport Realty Group LLC's (Newport) project at 55 Steele Boulevard, Newport is required to pledge the rents from 848 Farmington Avenue owned by their affiliate Newport 848 Farmington Ave LLC.

Newport 848 Farmington Ave LLC currently has a façade program grant in the form of a mortgage from the Town of Berlin that must be subordinated in order for Newport to obtain their financing.

Councilor Paonessa moved to authorize the Town Manager to execute a subordination agreement to Thomaston Savings Bank and Connecticut Housing Finance Authority with respect to the Town's mortgage from Newport 848 Farmington Ave, LLC related to a façade program grant that is recorded at Volume 773, page 226 of the Berlin Land Records, subject to the review and approval of Corporation Counsel.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

4. Topic re: Schedule a public hearing on May 20, 2025, at 7:00 pm to discuss a proposed Tax Abatement Ordinance as authorized by section 8-215 of the Connecticut General Statutes. – Town Manager

Town Manager Curley stated that the Ordinance Committee met earlier this evening to discuss a proposed Tax Abatement Ordinance authorized by section 8-215 of the Connecticut General Statutes.

This tax abatement ordinance will pertain to affordable housing and will allow Vesta to build senior housing on the previous Knights of Columbus property on Percival Avenue. Corporation Counsel Donofrio drafted an ordinance which the Ordinance Committee forwarded to Vesta for review. Vesta provided feedback which the Town Manager just received, and he shared that information with the Town Council at tonight's meeting and which is attached to these minutes.

Councilor Paonessa moved to schedule a public hearing on May 20, 2025, at 7:00 pm to discuss a proposed Tax Abatement Ordinance as authorized by section 8-215 of the Connecticut General Statutes.

Seconded by Councilor Veach.

5. Town Manager Curley stated that the Connecticut Neighborhood Assistance Act (NAA) Tax Credit Program provides tax credit to businesses that make cash investments in qualifying community programs conducted by tax exempt or municipal agencies. The programs must be approved by the municipality and the Department of Revenue Services.

This year three organizations have submitted proposals. The Prudence Crandall Center provides services to victims of domestic violence, schools and community groups. The Berlin Lions Charities, Inc provides financial support to Berlin Veterans and their spouses. CCARC, Inc provides services for individuals with intellectual and developmental disabilities.

Councilor Paonessa moved to support proposals from the Prudence Crandall Center, Berlin Lions Charities, Inc., and CCARC, Inc., for the 2025 Connecticut Neighborhood Assistance Act (NAA) Tax Credit Program and approve the setting of a Public Hearing for Tuesday, June 3, 2025 at 7:00 p.m. to discuss the proposals from the Prudence Crandall Center, Berlin Lions Charities, Inc. and CCARC, Inc., for the 2025 CT NAA Tax Credit Program and to solicit citizen input.

Seconded by Councilor Veach.

Vote being 7-0 (MOTION CARRIED)

Councilor Paonessa moved to designate Ryan Curley, Town Manager, the liaison for the Town of Berlin to handle all Neighborhood Assistance matters.

### K. TOWN MANAGER'S REPORT:

- Signs for the May 27<sup>th</sup> Budget Referendum have been ordered and will be put up throughout town.
- Declarations for the vacant units at the Town's mobile home park have been completed and the Town is waiting to hear back from the Department of Housing regarding the language. The goal is to get those recorded by June 30<sup>th</sup>.
- In order to follow through with the Blight Ordinance a Citation Hearing Officer must be appointed, therefore the Town Manager is asking the Town Council for recommendations for that position which is currently vacant. He added that the hearing officer cannot be a Town employee, and they must live in Berlin.
- The Finance Department received the Certificate of Achievement for Excellence in Financial Reporting award for fiscal year 2024. This is the 39<sup>th</sup> consecutive year that the Town of Berlin has received that award.
- A Consent item on the April 22, 2025 agenda for a Bike Race to take place at the Hatchery Brook Conservation Area mistakenly listed the date of the race as May 7, 2025 (rain date May 8, 2025). The actual dates will be June 7, 2025 with a rain date of June 8, 2025.
- The Town Manager provided the Town Council with copies of the proposed restructuring of the VNA space which was discussed at a prior meeting.
- As part of the Carbon Reduction Grant the Town's estimated \$3 million sidewalk proposal, based on square footage, was submitted to the Department of Transportation (DOT). Based on DOT's calculations of the square footage the project would cost \$3.8 million. The Town only needs to commit to the design work which is about \$160,000.

### L. SPECIAL COMMITTEE REPORTS:

The Ordinance Committee has met to discuss the tax abatement ordinance for affordable housing, and possible noise ordinance amendments.

### M. COUNCILORS' COMMUNICATION:

Councilor Pruzin inquired about results from the soil testing that was being done on the property across from the high school. Town Manager Curley stated that at a meeting held with the YMCA in early April their engineers were requesting information and it turns out that when design work was done for the proposed Senior Center at that location surveys were done. Public Works Director Mike Ahern is working to put that information together for the YMCA which will assist them in determining if they will

be able to build on the site. The Public Building Commission has it on their agenda to move forward with soil sampling.

Councilor Pruzin inquired about Charter revision in regard to the Budget Referendum as discussed earlier in tonight's meeting. Town Clerk Kate Wall reminded the Council that a Charter Revision Committee needs to be formed, and they need to determine what they want to look at.

Councilor Veach stated that the two things the Town wants to get bonded are in the packet at the State.

Councilor Coppola stated that the firefighters involved in fighting the Lamentation Mountain fire were honored by the State for their contributions. Mayor Kaczynski stated that a recognition dinner is being planned for the firefighters. Town Manager Curley stated that he has spoken with Jim Simons who mentioned that firefighters typically have a summer gathering so that might be a nice time to hold the dinner.

Mayor Kaczynski stated that three Town-sponsored concerts will be held this summer. Town Manager Curley stated the dates are June 26<sup>th</sup>, July 17<sup>th</sup>, and August 7<sup>th</sup>.

There will be an Open House at the Police Department on Thursday May 8th from 5:30 p.m. to 8:30 p.m.

A wreath-laying ceremony will be held at Maple Cemetery on Monday May 12<sup>th</sup> at 9:00 a.m. in memory of Officer Jeffery Casner.

Mayor Kaczynski stated that the slab moisture issue at the high school will be discussed at the Monday May 12<sup>th</sup> Board of Education meeting which will be held at Berlin High School at 6:00 p.m.

The America 250 Commission will be meeting on Thursday May 8th at 5:00 p.m.

### PUBLIC WILL BE INVITED TO ADDRESS THE TOWN COUNCIL WITH QUESTIONS AND CONCERNS AFTER THE PRESENTATIONS.

Mayor Kaczynski stated that he would defer discussion to representatives of Bright Feeds, DEEP, DPH, and SH Acoustics.

Jonathan Fife, Bright Feeds CEO, thanked everyone for working with the company through this period as they worked to address concerns with their facility. Since the March update, Bright Feeds has received and installed the thermal oxidizer in early April. By mid-April the thermal oxidizer was working as expected and they measured a more than 98% destruction rate for organic compounds which are compounds that produce odors. Bright Feeds also wanted to make sure that when the oxidizer was installed it was going to be a permanent sound solution, so they engaged a sound consultant. Measures were put in place which included rebalancing of the dryer fan by the manufacturer, installing custom sound blankets on all outside fans, adding four inches of mineral wool insulation on the ducting leaving the drying fan, and installing two custom designed silencers to further reduce noise. As of mid-April, they have been operating at full capacity.

Bright Feeds' fan consultant performed testing at the facility and around town, and they concluded that Bright Feeds was within the town noise ordinance and there were not any discrete tones.

Jake Felton, Director of the Air Enforcement Division, the Department of Energy and Environmental Protection (DEEP) stated that DEEP has remained in contact with Bright Feeds' representatives to continue to reinforce the importance of expeditiously eliminating nuisance odors and resolving the open violation notice. As of April 4<sup>th</sup>, Bright Feeds installed the regenerative thermal oxidizer which is commonly used to control emissions of volatile organic compounds which give rise to odor.

DEEP was on site the week of April 7<sup>th</sup> and witnessed Bright Feeds' contractor take stack measurements of volatile organic compounds which suggested a destruction efficiency in the high 90% range by volume. DEEP received odor complaints the week of April 7<sup>th</sup> and mild to moderate odors were documented in the immediate vicinity of Fuller Way. No new complaints of odors have been received since April 15<sup>th</sup>.

Earlier this year it was determined that Bright Feeds did require a Clean Air Permit and DEEP expects that they will continue to work to obtain a new source review permit.

Ambient data from a sophisticated dispersion model of stack pollutant concentration results should be available to the Department of Public Health next week for further analysis.

Pat Bisacky, Supervisor of Toxicology Group, Connecticut Department of Public Health (DPH) — Ms. Bisacky stated that once the data is received from DEEP a risk assessment will be done. Once that information is compiled it will be shared with the Town and DEEP.

Tessa Wearne, SH Acoustics – Ms. Wearne stated that Bright Feeds has implemented a number of adjustments which have significantly reduced air borne noise and vibrational transfer. SH Acoustics conducted both day and evening acoustic testing on April 28<sup>th</sup> and confirmed that Bright Feeds remains within compliance of the Town's established noise standards.

During their initial testing on January 30<sup>th</sup> SH Acoustics detected a low frequency originating from the main exhaust fan but following completion of the remedial work the low frequency along with other tonal noises are no longer present.

Ms. Wearne addressed the concerns raised about a low frequency tone of 20 Hz reported near the corner of Deming Road and Christian Lane. Frequency based measurements were taken in early morning and midday and their professional analysis confirmed that no 20 Hz tone was present.

### **Public Concerns and Questions:**

Ryan Molloy, 84 Juniper Lane – Mr. Molloy asked for clarification on the modeling by DPH of worst-case-scenarios being based on conditions residents encountered versus the current set of variables.

Mr. Molloy believes that Bright Feeds needs a compliance model that is sustaining. The Town of Berlin needs to revisit its' business licensing procedures with industry applicable questions asked and the Town's sound ordinance needs to be modified to account for low frequencies known to bother humans. He added that when something gets escalated within a State agency they need an urgency classification system correlated to the impact on citizens, and the State also needs to review the permitting system especially in relation to the Clean Air Act Permit.

Jim Ostroski, Tasca Ford employee – Mr. Ostroski thanked Bright Feeds for installing the new equipment. Although he occasionally notices a slight odor it is not like before. He requested that DEEP let the residents of Berlin know what penalty they impose on Bright Feeds when the time comes.

*Tyler Ciaffaglione, 520 Worthington Ridge* – Mr. Ciaffaglione stated that his family is occasionally smelling slight odors and added that his father works near the Bright Feeds building and the business is still smelling strong odors there.

Kathryn Mease, 15 Main Street, EB — Ms. Mease inquired about the legality of Bright Feeds continuing to operate without a Clear Air Act permit in place.

In response the questions asked, Mayor Kaczynski stated that the Town can investigate the licensing process and the sound ordinance is already being addressed by the Ordinance Committee. Town Manager Curley added that SH Acoustics and Corporation Counsel Donofrio are assisting with drafting that ordinance.

In response to the modeling assumptions, Jake Felton of DEEP stated that the numbers that are given to DPH represent the highest 24-hour average computed based on five years of meteorology at any location in the ambient air. The initial conservative emission rate is based on the highest run and the lowest flow rate and then they look at different iterations of that.

Regarding the penalty to be imposed, that is public information, it is published on their website, and the municipal CEO is notified. Regarding the permit question, under state law the lack of a permit is not grounds for a cease-and-desist order.

Mr. Felton added that emission factors exist for all types of facilities in the state, however one did not exist for this specific source category. Before DEEP can conclusively say a permit is required, emission factors are needed which is why a stack test was done. Bright Feeds is a unique situation as they are not burning anything, they are drying.

Kathryn Mease, 15 Main Street, EB — Ms. Mease asked if there was any information on the toxicology that can be shared tonight regarding VOCs from the stack.

Ms. Bisacky of the DPH stated there is no additional information at this time but it will be forthcoming. Mr. Felton added that the stack testing that is currently available is not meaningful from a health perspective at this time because it is what is coming out the stack and not what anyone is exposed to and that is what needs to be modeled. That modeling information will be available the next time we meet.

Mayor Kaczynski stated that when that information is available another meeting will be held to update the public. He thanked everyone for working together to get to this point.
